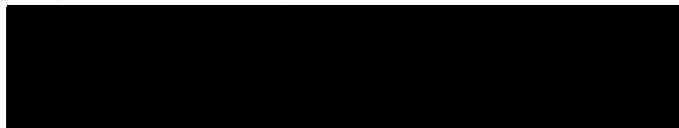

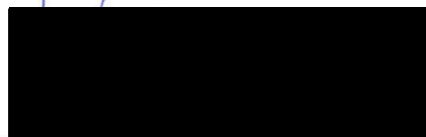
Further contractual arrangements:
