In the case of group bookings booked less than 60 days prior to arrival the first advance payment of 10 percent shall not apply and the total booking amount will be due in advance immediately after the reconfirmation of the booking by MEININGER Hotels.

Our preferred means of payment in hotels are cashless, exceptions may apply due to local legal requirements.

Cancellations

The deadline for free cancellations is 60 days before the day of arrival. This also applies if the contract is concluded within the deadline. Thereafter, cancellation charges are payable on the following terms:

- As from the 59th day prior to arrival 10 percent of the agreed booking amount is payable.
- As from the 29th day prior to arrival 50 percent of the agreed booking amount is payable.
- As from the 9th day prior to arrival 90 percent of the agreed booking amount is payable.
- For cancellations on the arrival day and for no-shows 90 percent of the agreed booking amount is payable.

Booked catering services may be cancelled free of charge up to 14 days prior to arrival. Thereafter, a cancellation fee of 100 percent of the agreed price will be payable.

The MEININGER standard conditions apply if no other agreements have been signed.
