Detailed justification of all relevant facts justifying the conclusion that the project cannot be continued at the current beneficiary's site

The Project Investigator has a postdoctoral position at the Current Beneficiary, but has started a tenure-track position at the New Organization. This tenure-track position is currently .2 FTE, but will increase to 1.0 FTE at the beginning of 2026. The Project Investigator cannot continue to pursue the grant at the Current Beneficiary while also working full-time at the New Organization, and so requests a change of beneficiary.

The project objectives and planned results will not be affected by the change in grant Beneficiary. The members of the research team plan to move their positions to the New Organization at the beginning of 2026, at the planned FTEs. The members include (PhD student, 0.5 FTE), (PhD student, 0.5 FTE), and (postdoc, 1 FTE). (postdoc, 1 FTE). (planning to re-join the project at the beginning of 2026 after her maternity leave.) This has been agreed to by the researchers themselves, the advisors of the PhD students, and statutory representatives at the Current Beneficiary and the New Organization.

The New Organization offers research support on par with the Current Beneficiary, including access to a computing cluster, access to publications, open access agreements with publishers, and arrangements for hosting visiting researchers. (When hosting visitors recently, we chose to meet primarily at the New Organization.) Because of the proximity of the Current Beneficiary and New Organization, it will be easy to maintain existing collaborations at the Current Beneficiary. Moreover, the change in workplace may spur new collaborations related to the project, particularly with Daniel Stránka 2 z 9Fussner on homogeneity and Jan Hladký on exchangeability.

The output of the project is going as planned, taking into account the standard delay of 1-2 years between first submitting a paper to a mathematics journal and its acceptance. The planned output was stated to be four results per year. In 2024, we posted five preprints, which have all been submitted, and two have been accepted. So far in 2025, we have posted five preprints, with three submitted and one accepted. We plan for all results submitted for publication by the end of 2025 to be allocated to the Current Beneficiary, and results submitted after the end of 2025 to be allocated to the New Organization.

The Current Beneficiary expects to use the full amount approved for years 2024 and 2025 costs in this year (2025). If the subsidy provided for 2024 and 2025 is not used in full, the Current Beneficiary will have to return the unused portion to the provider.
