The Lisensee and Cineflix hereinafter collectively referred to as "the Parties" or individually as "the Party".

Whereby it is agreed as follows:

- 1. Cineflix hereby agrees to grant to the Licensee the right to broadcast the Programme on the Licensed Service for the Number of Broadcasts in the Territory in the Language during the applicable Licence Period by the means of the Rights and upon the terms and conditions set out below.
- 2. The Programme Attachment ("The Attachment") attached hereto as Schedule 'A' is hereby incorporated fully into this Agreement between the parties dated 19<sup>th</sup> May 2009 (Ref: Cl0890) and shall apply to all future agreements entered into between the parties (except as varied by the relevant Attachment to such future agreement).
- 3. In the event of any conflict between the Attachment and the Standard Terms the Attachment shall prevail.



100% (one hundred percent) of the Materials Fee (342.22 Euros) due prior to delivery of Materials.

Licensee shall provide Cineflix with the relevant Tax Certificate as soon as is received.


- a) Licensee shall have the right to subtitle dub or voice-over the Programme(s) in the Authorised Language
- b) Licensee shall provide Cineflix with copies of the subtitled dubbed or voice-overs of the Programme(s) upon request. The copyright in any new material created by Licensee shall vest in Licensee but Cineflix shall have the irrevocable right to use the version supplied by Licensee subject to payment of

- c) Licensee may edit, re-edit, cut, modify or change the Programme in circumstances where editing would be required in order to conform to local social, cultural and religious requirement.
- d) The Ancillary Materials (noted above) relating to the Programme(s) shall be delivered to the Licensee via Cineflix's website: <a href="http://cineflixrightsmaterials.com">http://cineflixrightsmaterials.com</a>. For the purposes of this Agreement, "Delivery" in respect of the Programme(s) will be defined as the physical delivery to the Licensee of the Physical Material only. Therefore to take delivery of Ancillary Materials the Licensee should obtain login details from the materials contact (noted above) and visit the website for such access and delivery. If the Ancillary Materials are available on said website, such Ancillary Materials shall be deemed to have been delivered to and accepted by the Licensee, and Cineflix shall have no further obligations in respect of the Ancillary Materials. In the event that some or all of the Ancillary Materials are not available via the said website, then Cineflix shall deliver the Ancillary Materials by an alternative delivery method to be agreed between the parties.
- e) "Digital Terrestrial (DTT)" shall mean the delivery of the Licensed Service by means of over the air broadcasting by digital signals for reception by conventional roof-top and/ or set top aerials or other similar equipment which may or may not require a separate digital decoder.
- f) Not withstanding Clause 2 c) (iii) of the Standard Terms and Conditions, Cineflix hereby grants the Licensee Permission to directly translate the title of the Programmes in to the Authorised Language without first obtaining Cineflix's approval.
- g) Not withstanding Clause 2 c) (vi) c) of the Standard Terms and Conditions, Cineflix hereby grants the Licensee Permission to include a brief announcement introducing the next item in the broadcast schedule during the Programme transmission.
- h) Subject matter as well as price, or value, on the front page of this Agreement has no normative meaning; it has been conducted solely for the purpose of potential publishing of this Agreement in the Czech Registry of Agreements.
- Confidentiality: The Parties agree that the content of this Agreement including this Attachment and Standard Terms and Conditions (hereinafter as the "Agreement") as well as any information that may have come to either Party's attention during the process of negotiation preceding the execution of this Agreement and/or its fulfillment, is considered to be confidential and neither contracting Party shall be authorized to disclose to any third party such information without the prior written consent of the other Party. This prohibition remains in effect after the performance of the Agreement is completed or terminated, with the exception of information: (i) that came to the other Party's attention independently of the other contracting Party; (ii) that the Licensee provides to third parties in relation to the preparation, production, distribution and/or promotion of its program content to which this Agreement relates and/or in relation to its own promotion (with the exception of information marked by the Licensor as its trade secret); (iii) that a contracting Party provides or makes public based on a legal regulation or enforceable decision of a court and/or authorized administrative body; and (iv) that a contracting Party provides to its specialist advisors and/or other associates equally bound by the legal or contractual duty of confidentiality. Should this Agreement be or become subject to an obligation to make the contents of this Agreement public based on the Act on Registration of Agreements (Act No. 340/2015 of the Czech Collection of Laws - hereinafter as the "Act on Registration of Agreements") (for example, due to the execution of an amendment), information in this Agreement highlighted in yellow shall be redacted (blackened out) pursuant to the Act on Registration of Agreements upon mutual agreement. Such redacting shall be implemented especially in cases of, but not limited to, trade secrets that are subject to the appropriate measures of the Parties to keep such information confidential. Information not highlighted in yellow shall not be subject to the duty of confidentiality pursuant to

this provision. Only the Licensee shall be entitled to make this Agreement public pursuant to the Act on Registration of Agreements within the time period of 80 days commencing upon its execution. Provided that the Licensee does not make the Agreement public within this time period, either Party shall be authorized to make the Agreement public pursuant to the Act on Registration of Agreements. In the event of a breach of any obligation stipulated by this provision by either Party, the entitled contracting Party shall be authorized to claim a contractual penalty in the amount of without prejudice to the right for compensation of damage in full.
