



What is the need for this project?

Young university students have easy access to theoretical knowledge from various online resources. They are also well aware of simple personal applications especially in mobile environment. However, the opportunity to use real enterprise-wide information system is limited. The students are therefore lacking the ability to understand complex business processes and the role of IT is rather abstract or shallow. The possibility to gain better understanding and hands on practice is usually in their first job. This can have impact on their position on the job market and ability to see the challenges and spot the opportunities in today's business world.

#### Describe your project/programme

The project is a continued endeavor to raise awareness of ERP systems among young students and provide a hands-on practice on business like activities. Enterprise information systems such as SAP S/4HANA are the backbones of today's business operations. The SAP ERP (Enterprise Resource Planning) simulation game aims to build understanding of business production and sales processes and related IT operations. The game presents students a virtual market place in which students' teams represent competing companies. The student teams conduct the business processes through the SAP S/4HANA transactions. Thus, the game provides students with unique persuasive opportunity to gain management, economic and technology skills and competences that are vital for their future career. The simulation game is targeted at students of major Czech business and IT faculties. Currently, the students from the University of Hradec Králové, University of Economics Prague and the Czech

University of Life Sciences are participating in the game. The effort is made to involve also other Czech universities.

Demonstrate how your project/programme meets the need identified above and the objectives of this grant round or the mission of Community Foundation Ireland.

The project is focused on the "Building future skills". The beneficiaries will have a chance to get in touch with a real enterprise-wide system and follow a particular scenario of business actions. In that they will have the opportunity to deploy management skills to organize the team, team roles and their responsibilities as well as prepare a plan and conduct business activities to pursue the prepared plan. The economic skills will help the team members to understand current situation of the business and the necessary steps that should be undertaken in order to improve the financial situation and be competitive in the virtual market. The information technology skills enable the effective and efficient realization of the business activities and also brings opportunity for innovation. Further, the data and reports from business operations provide an opportunity to broaden the analytical skills necessary to steer the business in a competitive environment.

#### What are you hoping to achieve with your project? What are the three main aims or objectives?

To help students gain expertise on working with a real ERP System – the students will receive hands on practice using SAP ERP system. This will raise the awareness in how information system can help businesses to improve their operations.

To exercise business skills – students will have opportunities to participate in a virtual market and thus make decisions and perform actions to increase virtual company valuations. The decisions and actions are similar to what students can experience in the real world. The students will have a chance to apply analytical and critical thinking in order to succeed in the game.

To provide for collaboration and networking – the game assumes teams of students and therefore students will learn how to collaborate with other students to achieve given objectives. The students will also receive support from SAP employees and practitioners. This will provide students with an opportunity to join the SAP community and participate in processional networking. # Unique Value

Why is your organisation best placed to lead project?

The Faculty of Informatics and Management is building an expertise on teaching and organizing the simulation games using SAP ERP. The expertise is fairly unique among other Czech universities and we organize workshops for another 3 Czech universities. The faculty is also active in extending the partnership with SAP Czech Republic and other industry partners. This helps to broaden SAP skills among faculty members as well as incorporate specialized SAP technologies in such as machine learning, IoT, cyber security into study curricula. The funding is essential to maintain cooperation among universities and business partners.

#### How are your beneficiaries disadvantaged?

We believe the students of public universities are disadvantaged on the job market due to the lack of hands on practice with ERP systems. Especially in the Czech Republic, the public universities do not have funds to provide for the hands on training on real-world ERP systems. This is compared to students of private universities and business schools with more extensive funds. The lack of practical hands on exercises renders Czech students to be disadvantaged on the international job market compared to students in other countries with more profound business oriented curricula. The students are also disadvantaged in understanding of moderately complex and complex business scenarios for which practical experience is vital. Such students need longer induction periods and produce more errors at the beginning of their career. The lack of practical experience results in greater stress and more psychologically demanding conditions.

#### How will you identify individuals or groups that will be served by this project?

The beneficiaries will be the university students primarily but not necessarily in business and IT study programmes. In particular, four Czech public universities with business and IT oriented faculties will be involved and their students will be invited to participate in the project. There are no special prerequisites just a basic computer literacy. The participation will be voluntary and will be promoted by the faculty staff members in related courses and also using web and social media. The students will form their own groups of approximately 4-6 to cover the roles in the game.

#### How will you monitor and measure the impact of your project?

The project activities will be monitored by academic and business partners in project meetings. The outcomes will be reported also using simulation game results i.e. scores achieved in each game round. The impact on beneficiaries will also be gathered in the form of student's feedback (such as informal discussion and/or survey).

#### What will you do to ensure the success of this project?

The success of the project depends highly on communication with students and partners. Thus, the project coordination will focus on establishing proper communication channels with the partner university and also industry partners to organize the game events. Another, communication channels will be directed to students to promote the game and also to give instructions about participations. Best practices from previous years will be utilized and further extended. The success of the project is also related to game and technology provider. The technology checks with the provider will be exercised to achieve an appropriate user experience during the game.
