GENERAL TERMS & CONDITIONS

THIS CONTRACT IS BETWEEN THE REST UP LONDON, "THE HOSTEL", & "THE OPERATOR"

The accompanying pages are integral to the agreement between Airtree Ltd. T/A Rest Up and the Operator. This agreement shall be subject to the following conditions:

1. Rates are gross rates, non-commissionable, are per person per night and include service, VAT (20%) and breakfast as indicated. The inclusive VAT (within the agreed rates) is subject to change by government legislation. Based on those changes Rest Up reserves the right to make further modifications applicable only to Group travellers.
2. These rates are confidential, are not to be disclosed and they may not be published in isolation.
3. The rates are available for Group Leisure Traffic only. They may only be used to form the basis of a package or programme. Where appropriate, at least detailing such packages and programmes should be supplied to the featured hostel.
4. Bookings cancelled 30 days prior to arrival will be charged 100% of the stay. Deposits if applicable are non-refundable if cancelled. Any part of the 30-day cancellation and No-Show period will be charged.
5. Check-in will not be guaranteed before 15:00 hrs on the day of arrival. Departure time is no later than 10:00 hrs on day of departure.
6. The Operator will be charged for items listed on their voucher and agreed at the time of reservation. The guest will be charged for any items purchased by the voucher.
7. The Hostel, may where relevant, cancel any reservation or withdraw from this agreement:
 - a) if the hostel or any part is closed due to fire, dispute with employees, alterations, decoration or by order of any public authority or for any reason beyond the Hostel contracted;
 - b) if the agent becomes insolvent or if the Operator fails to meet the Hostels payment terms;
 - c) if it might prejudice the reputation of the Hostel;
 - d) or if the rates in this agreement are disclosed or sold directly to the public. Under no circumstances can this contract be amended without prior consent in which case a new contract will be issued.
8. Where the Hostel and the Operator sign each other's contracts, rates, terms and conditions, in the event of a conflict between the Hostels' contract conditions and the suppliers' contract, rates, terms and conditions, then the Hostel's contractual conditions will prevail.
9. The rates and terms and conditions of this contract are only to be used on a B2B model. In case the Operator sells these rates to another operator, the Operator has the right to cancel the contract with immediate effect and without penalty.
10. For all group bookings please revert directly to the Hostel's sales & reservations office only. No amendments will be made with any other team member.
11. All rates are quoted in Pounds Sterling and payments should be made by bank transfer only. International bank charges will also be included on the bill to be paid for by the client.
12. Rates valid for Group reservations only, subject to availability unless allocation has been agreed.
13. These rates must only be used to form the basis of a packaged leisure programme featured in a tour operator brochure.
14. This Contract is governed by the laws of England & Wales.
15. The Operator may not sell the above contracted rates directly to the public on the Internet, nor to other operators who sell to the public on the Internet. This condition will entitle the Hostel to terminate this contract without notice or penalty and the Operator will be financially liable for the difference between contracted rates and the group rates booked.
16. The group leaders shall indemnify Rest Up Hostel against any loss, damage, claims and expenses that may be suffered as the result of the misconduct of the group's participants.
17. The use of our Hostel name, brand and trademarks is strictly prohibited in connection with any radio, television, Internet marketing, or advertising without our express permission and approval. This includes the use of any of our Hostel Name, Brand, and Marks in conjunction with paid listings in search engines, meta tags, links and any other means intended to influence search engine results for interest searches invoking the Brand without Rest Up express permission as the Hostel reserves the right to terminate this agreement on ten (10) days' notice on breach of this clause.
18. Any hand-written amendments will automatically invalidate this contract. These rates will come into operation only once this agreement has been signed by the hostel.
19. The Hostel is entitled to capture data from its clients, to use for permission marketing.
20. Failure by the Hostel to enforce at any time the provisions of this agreement shall not be construed as a waiver of any of its rights nor affect the validity of the agreement nor prejudice the Hostel as regard subsequent action.
21. Rest Up Hostel is a non-smoking establishment; non adherence to this policy will result in a penalty charge of a minimum of £50.00 upon check out to restore the room as smoke free.
22. No pets are allowed in the Hostel. Only registered guide dogs will be allowed with permission from the sales team.
