All acts related to the publication of this Amendment in the register of contracts shall be ensured by the Customer.
3. This Amendment shall become valid on the date of its signature by both Contracting Parties and effective on the date of its publication in the register of contracts.
4. The Contracting Parties declare that they have read this Amendment, agree with its content, and that this Amendment has been executed clearly, comprehensibly, and based on their true, free, and serious will, without any duress. As evidence thereof, they affix their signatures.
