### I.

- The DLO negotiates this contract with the Guest Artist for **the four-day puppetry workshop "How to use object in education" within the project MeetLoutky continuing, No. 1561000062**, with the financial participation of the Ministry of Culture of the Czech Republic.
- The workshop will take place on **7-10 December 2025** at the DLO.

### II.

- The DLO will pay the guest artist a fee of GBP 1642,00 (GBP One thousand six hundred and forty-two) and a travel allowance of GBP 200,00 (GBP Two hundred) for the agreed artistic workshop during the said period.
- For the purposes of the Income Tax Act No. 586/1992, as amended, the above remuneration is income of the guest artist under Section 7(2c).
- Since the Visiting Company does not have a permanent establishment in the Czech Republic, the agreed fee shall be subject to taxation in UK, according to Article 7 of the Double Taxation Treaty between the Czech Republic and United Kingdom of the Great Britain and N. Ireland (Communication No. 89/1992 Coll. of International Treaties, from the Ministry of Foreign Affairs of the Czech Republic). By signing the Contract, the Visiting Artist confirms that it is the beneficial owner of the said fee.
- DLO is an identified person according to the provisions of Section 6h of Act No.235/2004 Coll., on Value Added Tax; and according to the provisions of Section 108(1)(c)(1) of this Act, DLO is obliged to declare and pay VAT at the statutory rate.

- The said remuneration of the total amount of GBP 1842,- (in words: GBP One thousand eight hundred and forty-two) shall be paid no later than 15 December 2025 by transfer to the Visiting Artists' account [REDACTED]
- Bank charges will be shared.

### III.

- The guest artist undertakes to comply with the DLO's working regulations, occupational health and safety regulations and fire safety regulations, which he/she was informed of when concluding the contract for the creation of the work, during the period of the guest artist's stay at DLO.
- The DLO undertakes to create, at its own expense, all the necessary prerequisites for the agreed artistic performance.
- This contract shall be governed by the applicable Czech law, in particular the relevant provisions of the Copyright Act and the Civil Code.
- Disputes concerning claims arising out of or in connection with the performance of this contract shall be decided by the courts unless resolved by agreement of the parties.
- This Agreement shall enter into force upon signature by the authorised representatives of both Parties. Amendments and additions to it must be made in writing and must also be signed by both authorised representatives of the Parties.
- The Parties undertake to continue to act in accordance with the current legislation in force and in force when managing and processing personal data.
