- C. Following any such upgrade, Customer agrees that the upgraded tier shall become the new Minimum Fee for the remainder of the Order Form Term, and Customer may not downgrade from the then-current Tier to any lower tier during the Order Form Term.
- D. Prices for Services not listed in the Fees table above are set forth at https://elevenlabs.io/scale-tier.
- E. ElevenLabs reserves the right to modify the Fees under this Order Form at the end of the Initial Term or the then-current Renewal Term upon 30 days prior written notice to Customer (which may be sent by email).

5. Other Fees.

A. **Additional usage volume:** For each Tier, any usage exceeding the volume covered by the monthly Minimum Fee will be charged at a Flexible Usage Rate, which applies the percentage premium specified in Section 4(B) to the applicable committed rate pricing for each Service.

B. Agents – Third-Party LLM Costs:

a. ElevenLabs will pass through to Customer all fees associated with specific LLM providers and the usage of applicable LLM models.

C. Agents - Burst Pricing.

- a. Calls within Concurrency Limit. Customer's usage of ElevenLabs' Agents product within the subscription-based concurrency limit (the "Concurrency Limit," as set forth in the Fees table in Section 4(B) of this Order Form) will be charged at the standard per-minute rate specified in the Fees table (the "Standard Agents Rate").
- b. Burst Call. ElevenLabs permits Customer to exceed the Concurrency Limit up to a defined "Burst Limit," which is equal to the lower of (i) three (3) times the Concurrency Limit and (ii) 300. For example, if the Concurrency Limit is 30, the Burst Limit would be 90; if the Concurrency Limit is 120, the Burst Limit would be capped at 300. Calls exceeding the Concurrency Limit but within the Burst Limit ("Burst Calls") will be charged at 2x the Standard Agents Rate. The Burst Limit set forth herein is subject to change by ElevenLabs with reasonable notice.
- c. Priority and Service Levels. Burst Calls are processed on a lower-priority basis compared to calls within the Concurrency Limit and are not subject to ElevenLabs' Service Level Agreements applicable to the Agents product.
- d. Use Exceeding Burst Limit. Calls that exceed the Burst Limit will be rejected. ElevenLabs does not guarantee capacity for usage beyond the Burst Limit and makes no commitment to support such traffic.

6. Payment Terms.

A. ElevenLabs will invoice Customer on Start Date and on the same day as the Start Date every month thereafter for the Fees listed above. Customer will pay the Fees within 30 days of the invoice date. Other Fees will be invoiced in the immediate next invoice after they are incurred.
