### Addendum No. 1 to the Purchase Agreement

(hereinafter referred to as the "Addendum")

#### **PREAMBLE**

- The Seller is the economic operator selected to provide delivery under the public contract titled "QKD devices for backbone network CZQCI" (hereinafter referred to as the "Public Contract"), awarded by the Purchaser, in an Open Procedure, pursuant to Section 56 of the Act No. 134/2016 Coll., on Public Procurement, as amended (hereinafter referred to as the "PPA").
- 2. The Public Contract is financed by the European Union under the Digitální Evropa (Digital Europe) programme and the Czech National Recovery Plan.

## I. Justification for the conclusion of the Addendum

The Contracting Parties have agreed to implement the Addendum to the Agreement.

The Contracting Parties found that it was necessary to make Changes within "de minimis" regime as per Section 222(4) of the PPA, which are described below in this Addendum:

## II. Description of Changes and their classification according to PPA

### Change 1 (original Sec. I/2 of the Agreement):

The Purchaser requested the delivery of the remaining 4 pairs of QKD devices. This addendum replaces the Purchaser's request for the delivery of 4 QKD device pairs as contemplated in <u>Sec. I/2 of the Agreement.</u>

### Change 2 (original Sec. III/1 of the Agreement):

The first delivery of 7 QKD pairs shall be split into two separate shipments, as the Purchaser requires the equipment earlier than originally agreed upon in order to meet milestone and the *Czech National Recovery Plan (NPO)* project objectives. This change entails additional shipping/customs costs on the Seller's side.

The Seller is obliged to deliver the Equipment this way:

- 4 QKD pairs shall be delivered no later than 1st November 2025 (already delivered);
- 3 QKD pairs shall be delivered no later than 7th January 2026;
- 3 QKD pairs shall be delivered no later than 7th March 2026; and
- 4 QKD pairs shall be delivered no later than 30<sup>th</sup> April 2026.

### Change 3 (original Sec. III/3 of the Agreement)

# III. Impact of Changes on the Price of the Equipment

The expected costs for extra shipment of 3 QKD pairs, as the result of splitting the first delivery of 7 QKD pairs under Change 2, which will be covered by the Purchaser are: EUR 1,824.00
