



## Subcontract

Between Mobiel 21 and Transport Research Centre (Centrum dopravního výzkumu, v. v. i.) for the implementation of the approved CIVINET Annual Plan 2026 for CIVINET Czech and Slovak Republics

This Subcontract is entered into by:

**Mobiel 21 vzw** (VAT BE0423.517.539), with its registered office at Vital Decosterstraat 67A/0101, 3000 Leuven, Belgium, represented by Mrs Els Van den broeck, Managing Director, hereinafter referred to as "Mobiel 21",

and

**Transport Research Centre (Centrum dopravního výzkumu, v. v. i.)** (VAT Number: CZ44994575), with its registered office at Líšeňská 33a, 63600 Brno, Czech Republic, represented by Mr. Jindřich Frič, Director, hereinafter referred to as "Transport Research Centre".

Together referred to as "the Parties".

The Parties have agreed to enter into this Subcontract under the terms and conditions specified below. By signing this Subcontract, both Parties accept its content and agree to implement the activities outlined herein under their respective responsibilities, adhering to the obligations and conditions set forth.

This Subcontract becomes effective upon the signature of both Parties and is subject to the following terms:

1. Mobiel 21 grants this Subcontract for the implementation of the approved application submitted by Transport Research Centre as responsible Secretariat of CIVINET Czech and Slovak Republics under the CIVINET Annual Plan 2026 call, with a maximum funding amount of EUR 13.000,00.
2. Transport Research Centre will act as the contracting entity responsible for utilising the funding for the implementation of the CIVINET Annual Plan 2026.
3. Transport Research Centre agrees to adhere to its submitted and approved application for the CIVINET Annual Plan 2026.
4. Any adjustments to the planned actions must be justified in an Activity and Financial Report to be delivered by Transport Research Centre following the completion of the activity period.
5. An advance payment of EUR 8.000,00 will be made upon receipt of the signed Subcontract and the first invoice. The remaining amount will be disbursed following the delivery and evaluation of the fully completed and approved Activity and Financial Report, as well as the receipt of the final invoice. Payments will be processed using the bank account details provided in the respective invoices.
6. Transport Research Centre must conduct all activities in line with the spirit and objectives of the CIVITAS Initiative and ensure maximum added value.
7. Transport Research Centre must include the following funding statement for any activities supported by this Subcontract: "*Funded by CIVITAS MUSE via an Annual Budget*" for fully funded activities or "*Co-funded by CIVITAS MUSE via an Annual Budget*" for co-funded activities. Furthermore, the CIVITAS Initiative must be acknowledged by displaying its relevant logo on all applicable materials and communications.
8. In cases of irregularities, failure to carry out activities, or fraud, the awarded grant may be reclaimed or reduced.
9. Mobiel 21, as the beneficiary of the CIVITAS MUSE project, is required to act in accordance with its Grant Agreement (number 101103716) at all times.
