1. Purpose of the Agreement

The purpose of this Agreement is to formally confirm the participation of SoundCzech as a Member of the European Music Exporters Exchange (EMEE) for the year 2025, and to define the terms of payment of the annual membership fee.

The Agreement outlines the rights and obligations of both Parties in relation to the Member's financial contribution and continued participation in the Network's activities.

2. Membership Fee

2.1 The Member agrees to pay an annual membership fee to the Network in the amount of two thousand euros (2,000 EUR) for the year 2025.

2.2 The membership fee contributes to the operational and administrative costs of the Network, including coordination, communication, and joint project development.

2.3 Payment details shall be as follows:

2.4 The payment shall be made within 60 days of signing this Agreement, unless otherwise agreed in writing between the Parties.

3. Rights of the Member

By paying the membership fee, the Member retains all rights associated with EMEE membership for the calendar year 2025, including but not limited to:

- Participation in EMEE's activities, projects, working groups in Groningen (NL), Sopot (PL), Hamburg (DE) and Zurich (CH), consultation and active participation in discussions related to EMEE activities.
- Representation in the General Assembly and eligibility to vote on decisions;
- Access to shared internal communications and documentation;
- The right to use EMEE's membership status and logo in accordance with the Network's communication guidelines.

4. Obligations of the Network

The Network undertakes to:

- Ensure transparent management of the membership contributions;
- Keep Members informed of the Network's activities, plans, and financial overview;
- Facilitate collaboration, knowledge exchange, and joint initiatives among Members;
- Provide visibility for Members in EMEE's communications and promotional materials where appropriate.

5. Duration and Validity

5.1 This Agreement enters into force on the date of signature by both Parties.

5.2 It remains valid until all obligations under this Agreement are fulfilled, particularly the payment of the membership fee for 2025.

5.3 Renewal of membership for subsequent years shall be agreed upon separately, subject to the Member's continued participation in the Network.

6. Termination

Either Party may terminate this Agreement by written notice in case of a material breach of its terms. In case of termination after payment, the membership fee is non-refundable, unless otherwise agreed by the Network's Board.

7. Final Provisions

- Any amendments or additions to this Agreement must be made in writing and signed by both Parties.
- This Agreement is governed by the laws applicable in the country of the EMEE Secretariat's legal seat.
- The Agreement has been drawn up in two identical copies, one for each Party.
- Both Parties declare that they have full authority to enter into this Agreement.
