7.1.

The warranty period for Products is twelve 12 months from when operated in accordance with Orbit's operating instructions. (the "Warranty Period").

7.2.  
Orbit warrants that the Products sold hereunder are free from defects in material and workmanship, subject to normal use and service, during the Warranty Period. Orbit's sole obligation under the foregoing warranty shall be, at its sole discretion, limited to the following (a) repairing or replacing any component which fails during the Warranty Period free of charge, and/or (b) crediting all or a portion of the purchase price to the Purchaser; all, provided that (i) Purchaser has promptly reported such failure to Orbit in writing in accordance with the Orbit Return Material Authorization procedure (during the Warranty Period), (ii) the defective Product is properly packed and returned by the Purchaser to Orbit (transportation and insurance prepaid), and (iii) Orbit, upon inspection and at its sole discretion, establishes to its satisfaction that the component is in fact defective in materials or workmanship, and the damage was not cause by any misuse, negligence, improper installation, accident, or (unless authorized in writing by Orbit) repair or alteration.

7.3.  
All warranties, whether express or implied, extend only to the Purchaser and no others.

7.4.  
Orbit shall be relieved of any and all obligations and liabilities under the warranties specified in this Article 7 with respect to any Hardware or Licensed Software regarding one or more of the following has occurred (i) has not been subject to normal use at all times, including, without limitation, has been subject to negligent use or to abuse; (ii) has been subject to a natural disaster; (iii) has not been installed, operated, used or maintained in accordance with the accompanying Documentation; (iv) has been opened, repaired, altered or modified without Orbit's prior approval; (v) has been operated or used with any non-Orbit software or has been installed, operated or used with any accessory, Products or part not specifically approved by Orbit, not manufactured by Orbit, or not manufactured according to Orbit's design and specifications; (vi) the Hardware sent for repair is defined as "No Failure Found", following applicable tests; (vii) the magnetic media on which the Licensed Software is recorded have been subjected to damage or abuse.

7.5.  
The warranty service is performed at Orbit's premises (including any of its warranty services centers). Purchaser shall deliver the Product or components thereof to Orbit per delivery terms of CIP [closest international airport to Orbit's such premises or warranty services center] (INCOTERMS 2010). Orbit shall return the repaired or replaced Product or components thereof to the Purchaser per delivery terms of CIP (INCOTERMS 2010). No warranty service shall be commenced unless Purchaser first obtains a Return Material Authorization number, which will be furnished by Orbit upon request.

7.6.  
The warranty period in respect of repaired or replaced Hardware shall be the longer of (i) six (6) months from the repair/ replacement date, or (ii) the Product's remaining original Warranty Period. Any Product or components thereof replaced shall become the property of Orbit.
