

**AMENDMENT No. 1 - REPAYMENT AGREEMENT  
SU – VSB – Technical University of Ostrava (VSB)**

**BETWEEN :**

**Sorbonne Université,**

A public establishment of scientific, cultural and professional nature, located at 21 Ecole de Médecine, 75006 Paris, France, represented for the purposes of signature of this agreement by **Professor Nathalie Drach-Temam**, President of Sorbonne Université, of the one part,

hereafter referred to as "**SU**"

on the one part,

**AND**

**VSB – Technical University of Ostrava (VSB),**

established in 17. Listopadu 2172/15, 708 00 Ostrava – Poruba, CZECH REPUBLIC, represented for the purposes of signature of this agreement by Prof. Igor Ivan, PhD., Rector on the other part,

hereafter referred to as "**VSB**"

on the other part,

SU and VSB are hereafter referred to as "Party(ies)".

**CONSIDERING**

- The Repayment Agreement signed between SU and VSB on July, 18, 2024 (hereinafter referred to as the "Repayment Agreement") ;
- That SU, as Work Package 5 leader of the EUMaster4HPC project, is responsible for supporting the organisation of events, including summer schools, and holds a designated financial envelope to do so;
- That SU has transferred to VSB a budget intended to support the organisation of the 2024 EUMaster4HPC summer school, pending the validation of expenses by the EuroHPC Joint Undertaking at the end of Reporting Period 2.

**It is hereby agreed that:**

**ARTICLE I - ORGANISATION OF THE SUMMER SCHOOL**

VSB has been selected on the basis of its project proposal "EUMaster4HPC Summer School: HPC in Data Science" to host the EUMaster4HPC 2024 summer school, which will take place from August 17th to 25th, 2024, on the VSB campus in Ostrava, Czech Republic.

As leader of Work Package 5, SU is responsible for supporting the organisation of project events and holds a dedicated budget for this purpose.

SU has therefore granted VSB a budget to cover the expected costs of the summer school. VSB has

declared the incurred expenses within Reporting Period 2 (July to December 2024), and the reimbursement by the EuroHPC Joint Undertaking will take place after official approval of this reporting period (October 2025).

### **ARTICLE II - Obligation to Reimburse the Advance**

As a consequence, VSB, unconditionally and without reservation, commits to reimburse SU the full amount received (EUR 34.491,25 – thirty-four thousand euros and four hundred ninety-one and twenty-five cents), transferred as defined in the frame of the Repayment Agreement.

Reimbursement shall be made no later than 1 month after receiving the payment after reporting period 2 from the EuroHPC JU on behalf of VSB in the name of the accounting officer to the account of SU.
