### **Article I – Introductory Provisions**

1. The Parties confirm that on 25 August 2025 they entered into the above-specified framework agreement (hereinafter the "Framework Agreement").

### **Article II – Subject of the Amendment**

1. The subject of this Amendment is a non-substantial modification of the obligation within the meaning of Section 222(4)(b) of Act No. 134/2016 Coll., on Public Procurement, as amended.



This modification consists in extending the list of supplied items by additional items that were not part of the original list of tendered items.

2. The change is made due to the need for these items for the purposes of the grant project and the expansion of the laboratory equipment necessary to achieve the established research objectives.
3. The value of these additional items does not exceed 10 % of the original value of the obligation under the Framework Agreement, and the overall nature of the public contract remains unchanged.

### Article III – Scope of Additional Items

1. The list of newly added items is set out in the Seller's price quotation, which constitutes Annex No. 1 to this Amendment.
2. All other pricing arrangements, payment, and delivery terms shall be governed by the Framework Agreement.

### Article IV – Final Provisions

1. This Amendment constitutes an integral part of the above-mentioned Framework Agreement.
2. All other provisions of the Framework Agreement not expressly affected by this Amendment shall remain unchanged and in full force and effect.
3. The Amendment shall enter into force on the date of signature by the authorized representatives of both Parties and shall become effective on the date of its publication in the Register of Contracts pursuant to Act No. 340/2015 Coll., on the Register of Contracts, as amended.
