Engagement Contract (hereinafter referred to as the "**Contract**):

Preamble

The Client is the possessor of grant for mobility project called "Floristika v Holandsku", project no.: 2017-1-CZ01-KA102-034552 (hereinafter referred to as the "Project"), which is granted by National Agency for European Educational Programmes. The subject of the Project is training internship abroad of the Client's students.

The Contractor is a foreign partner who provides services connected to coordination of the internships mentioned above. Contractor provides and arranges trainings for the Client's students in its own premises and other two cooperating companies.

Article 1

Scope of Work

1.1. The Contractor will provide the Client with these undermentioned services:

- 1.1.1. Arrangement of and payment for accommodation for 14 (fourteen) Client's students and 1 (one) Client's Accompanying person [15 (fifteen) persons together] (hereinafter referred to as the "Person" or "Persons") for the term from October 22nd, 2017 (arriving date) till November 7th, 2017 (departing date). The accommodation is situated at The Chalets Florida and consists of central heated chalets with three bedrooms, living room, kitchen and bathroom (with shower, toilet and sink), a coffee machine and a fridge in the basic equipped kitchen. There is a television in the living room. Each bedroom consists of two single beds; two of them with a bunk bed, one with two single beds which can be put together. There are mattresses, blankets and pillows inside the rental accommodations including bed sheets.
- 1.1.2. Arrangement of and payment for transport from the place of accommodation to the place of training for each Person on each day of their training.
- 1.1.3. Arrangement of and payment for meals at least 3 (three) times a day (breakfast, lunch, dinner) and drinks at least 2 (two) litres a day for the Persons on the dates specified in part 1.1.1. of the Contract.
- 1.1.4. Arrangement of and payment for the trainings for each student specified in part 1.1.1. of the Contract in the extent of 10 (ten) days per the whole stay (specifically October 24th – October 28th, October 31st – November 5th, 2017) and at least 5 hours per each day of training. The trainings take place at the companies specified in the Preamble of the Contract. Accompanying persons won't be trained on these trainings but will be granted to take place on them. Scheduled program is as follows:

Sunday, October 22 nd	Arrival at Amsterdam
Monday, October 23 ^d	10.00 – 15.45, welcome to the Boerma Instituut® and lesson in Dutch hand tied bouquets
Tuesday, October 24 th	09.00 – 18.00, going to work in the flower shops
until October 28 th	09.00 – 18.00, working in the flower shops
Sunday, October 29 th	free time
Monday, October 30 th	07.30 – 15.45, Flower auction and lesson table arrangements at the Boerma Instituut®
Tuesday, October 31 st	09.00 – 18.00, working in the flower shops
Until; Saturday Nov. 4 th	09.00 – 18.00, working in the flower shops
Sunday, November 5 th	Free time
Monday, November 6 th	10.00 – 16.00, working in the flower shops
Tuesday, November 7 th	Going home.

Arrangement of and payment for transport from Amsterdam, Schiphol (place of arrival and departure) to the place of accommodation and back for the Persons on the dates specified in part 1.1.1. of the Contract.

Article 2

Rights and Duties of the Parties hereto

Rights and Duties of the Client

- 2.1. The Client is obliged to provide the Contractor with all information Contractor would ask for to execute the Work.
- 2.2. The Client is obliged to pay for the Work specified in part 1.1. of the Contract the price quoted in part 3.1. of the Contract.

Rights and Duties of the Contractor

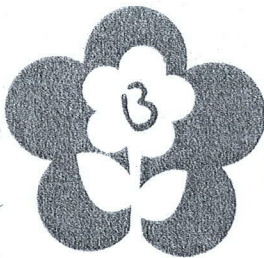
- 2.3. The Contractor is obliged to execute the Work at their own expense and own risk within the agreed period.
- 2.4. The Contractor is obliged to provide the Client with the Work specified in Article 1 of the Contract.

Article 3

Contractor's Remuneration and Payment Conditions

- 3.1. The Price of Work is 1390 EUR (one thousand three hundred ninety euro) per student and 1150 EUR (eleven hundred fifty euro) per Accompanying person for arrangements specified in parts 1.1.1. to 1.1.5. of the Contract. The total Price of Work is 21.760,- EUR (twenty one thousand seven hundred and sixty euro).
- 3.2. The invoice for the total Price of Work specified in part 3.1. of the Contract will be issued by the Contractor before the training. The Client will pay the invoice due to no longer than 14 days after issuing such invoice. The total Price of Work will be paid as a deposit.
- 3.3. Should the Contractor doesn't provide the Client with the Scope of Work specified in Article 1 of the Contract, the Parties hereto agreed on penalty in no payment of the services not provided by the Contract.

- 4.1. The Contract becomes valid on the day when being signed by both Parties hereto.
- 4.2. The Contract is made for the definite time period, till the moment of fulfilment of the obligations by both Parties hereto.

Article 5

Final Provisions

- 5.1. The Contract has been drawn up in conformity with the Czech legislation and shall also be governed by the Czech legislation. The Contract has been made in English in 2 (two) counterparts, each of them having the validity and force of the original, one counterpart for each Party hereto.
- 5.2. The Contract can be changed by the written amendment only signed duly by the Parties hereto.
