

5 Agreement

Declaration of organiser agreement

1. Messe Düsseldorf provides the organiser with the opportunity to organise a group stand at the above event. The organiser does not become an exhibitor.
2. The organiser applies for 90 qm floor space in accordance with the conditions of participation. The organiser has no right to a particular stand location and/or size. This contract cannot be rescinded.
3. All new companies wishing to exhibit on the area must apply to Messe Düsseldorf individually using the "online application for participants on a group stand". Messe Düsseldorf checks that they are eligible for the event and subsequently advises the organiser accordingly. Only those companies which have been checked and deemed eligible may become exhibitors and be allocated space in the group by the organiser. The organiser must inform Messe Düsseldorf of the size of stand allotted to each participant. This information must be provided to Messe Düsseldorf by the registration deadline for the event in the form of a list stating the size in square metres for each participant.
4. The organiser as well as each individual participant must acknowledge and adhere to the Messe Düsseldorf regulations applicable to the event and/or to the Düsseldorf exhibition centre itself. The relevant regulations can be accessed on the Messe Düsseldorf website www.messe-duesseldorf.de and on the website of the relevant event. The regulations can also be obtained by contacting Messe Düsseldorf.
5. The organiser is entitled to use Messe Düsseldorf or event trade marks and titles in order to promote the participation of the exhibitors. Use for personal purposes is not permitted.
6. The organiser is obliged to co-operate with Messe Düsseldorf and third parties authorised by Messe Düsseldorf in order to ensure that organisational procedures are adhered to. The organiser shall ensure that group stand participants will not prematurely abandon their stands while the trade fair is still in progress. A stand shall be considered prematurely abandoned if – during opening hours for visitors and before the end of the trade fair – it is no longer staffed, if exhibits have been removed or packed or if stand inventory has been dismantled or removed. Should a group stand participant prematurely abandon their stand, then the organiser shall be liable to pay Messe Düsseldorf a contractual penalty of € 1,500. A further contractual penalty of € 1,500 shall be payable for each additional group stand participant who has prematurely abandoned their stand. The overall contractual penalty that is payable by the group stand organiser shall not exceed the amount of € 15,000.
7. The organiser is obliged to fully reveal to the individual participants the prices which Messe Düsseldorf invoices to these participants for services supplied. All prices are exclusive of German VAT.
8. The organiser is required to pay the space costs and any multi media fees for participants on the group stand. These are payable once the participants have been officially admitted to the show. The organiser pays all costs incurred by the group. Pursuant to the "Special Terms and Conditions for Participation" the organiser will receive an advance payment invoice for technical services appropriate for the event.
9. The participants in the joint stand will be given the right to order free services from Messe Düsseldorf independently (Internal: type K).
10. The organiser shall receive from Messe Düsseldorf a number of free exhibitor passes – in accordance with the size of the exhibition space – as per the terms and conditions of participation as well as 2 further free exhibitor passes per participant in the joint stand; these are for forwarding to the participants in the joint stand.
11. All claims of the organiser – with the exception of liability in the event of malice aforethought – against Messe Düsseldorf become obsolete within 6 months, starting from the end of the month in which the last day of the event occurs. The place of performance and jurisdiction for all mutual obligations is Düsseldorf or, at the request of Messe Düsseldorf, the jurisdiction of the organiser. This also applies to actions under the Bills of Exchange/Cheques Act. The law of the Federal Republic of Germany has jurisdiction over these regulations. The German text is binding.
