

PERFORMANCE CONTRACT

Agreement made between the undersigned.

The Promoter:

Mr. **Luděk Strašák** on behalf of the **Městské kulturní středisko (Town Cultural Center) in Namest nad Oslavou**, IC: 18127746, located in Namest nad Oslavou, Masarykovo namesti 100 (Czech Republic), VAT number: CZ 18127746

and

The Artist:

WÖR & Kongero

Represented by **Bert Ruymbeek**, on behalf **vzw AWA**, located in Albrecht Rodenbachstraat 55, 9040 Sint-Amandsberg, Belgium; Belgian identification number: 0680699379, BTW/VAT: BE0680699379;

The Artist declares that he is not a payer of value added tax (VAT).

The list of musicians and their tax domiciles is included in Appendix No. 1

Here in after named respectively as «Promoter» and «Artist», it is agreed that:

1. The Artist, composed of n. 8 person on the road, agrees to appear as known for n. 1 performance held on **July 28, 2026**, n. 3 workshops held on **July 27-29, 2026**, n. 1 participation at the musicological colloquy held on **July 28-29, 2026** in **Namest nad Oslavou** (Czech Republic) as a part of Folk Holidays Festival 2026 in Namest nad Oslavou.
2. For the above-mentioned performances, The Promoter grants the Artist a fee (including artist's fee, production cost, booking fee and international travel cost) corresponding to the total amount 4.500 EUR net of any taxes. For the participation at the musicological colloquy is dedicated 1800 EUR from this total amount.
3. The total amount consists of:
 - a. Artists' fee: 2.000 EUR net of any taxes
 - b. Production cost: 750 EUR net of any taxes
 - c. Booking fee: 750 EUR net of any taxes
 - d. International travel cost: 1000 EUR net of any taxes
4. The Promoter will arrange, in addition, catering and accommodation in hotel: 8 single rooms OR at least 3 double rooms and 2 single rooms on July 26-29, 2026.

5. The Promoter will arrange and pay, in addition, local transport from Vienna or Prague airport to Namest nad Oslavou (arrival on July 26, 2026) and back on day of departure (July 30, 2026).
6. The Promoter will effect the payment of the sum here above mentioned - point n. 2 and 3 - by electronic bank transfer as follows:
 - payment of 1500€ will be paid to the Artist no later than March 31, 2026
 - payment of 3000€ will be paid to the Artist no later than July 28, 2026

7. The Promoter will arrange and pay sound, lights and backline according to the rider.
8. All shows of the Folk Holidays festival will be recorded by the Promoter – the purpose is only the festival’s archive. Every usage for public is under permission of the Artist.
9. Cancellation by Force Majeure: If the performance(s), object of this contract, cannot take place in whole or in part due to any reason considered by International Law as a Force Majeure or any other event beyond the Promoter’s and The Artist’s control, neither party shall have the obligation to fulfil the original contract and both parties will be exempted from their obligations. Each party shall bear its own expenses and no damages shall be claimed. In the case that money was advanced to The Artist by The Promoter, it should be returned to The Promoter in the shortest delay.
10. The present contract of agreement is valid if sent by email 1 scan copy of it is to be signed for acceptance and returned within February 28, 2026.
11. The file with rider, including the request for backline, the stage plan is an attachment to the contract.

This simple contract will be published in the Register of Contracts under Act No. 340/2015Sb. on the Register of Contracts. The publication will be provided by the Promoter.
