have agreed as follows:

The following provisions of the Grant Contract – External Actions of the European Union - NDICI-GEO-NEAR/2023/444-419/PC-26461-0013 concluded between the contracting authority and the beneficiary on 06/11/2025 (the ‘contract’) are hereby replaced/supplemented as follows:

Article 4 — Reporting and payment arrangements

- 4.1 Payments shall be made in accordance with Article 15 of Annex II option no. 1 as set out in Article 15.1bis:
- Initial pre-financing payment: 80 percent of the amount specified in the Article 3, EUR 41 400,00.
 - Second pre-financing payment: 20 percent of the amount specified in the Article 3, EUR 10 350,00. The second initial pre-financing shall be paid on the basis of the signature of the addendum 1 to the Agreement.
 - Balance of the final amount of the grant: 0 percent of the amount specified in the Article 3, EUR 0.

Article 5 – Contact Points

- 5.2. For the purpose of Article 1.3 and 1.4 of Annex II, for the part of the data transferred by the contracting authority to the European Commission the controller for the processing of personal data carried out within the Commission is the Head of the Contracts and Finance Unit of the Directorate-General for Enlargement and the Eastern Neighbourhood (ENEST.R.4).

Article 7 — Other specific conditions applying to the action

- 7.2. The following derogations from Annex II shall apply:
- 7.2.1 By derogation to Article 15.7 of Annex II the requirement for financial guarantee is waived.
- 7.2.2 By derogation to Article 15.1 of the Annex II the total amount of initial and second pre-financings is totally 100 percent in Article 3.1 of the Special Conditions, excluding not authorised contingencies.

7.2.3 The no-profit rule shall not apply to this contract (or part of this contract), according to Article 17.7 of Annex II for the following reason:

- the action is implemented by non-profit organisations;
- the action is for study, research or training scholarships paid to natural persons;
- the action is a direct support paid to natural persons in most need, such as unemployed persons and refugees;
- the action includes financing not linked to costs.

All other terms and conditions of the contract remain unchanged. This addendum shall enter into force on the later date of signature by the parties.
