Contract
on cooperation under a project funded by the International Visegrad Fund's
V4 Generation Mobility Mini-Grant No.12520088

between:

1. The Grantee - „Dla Ekonomika” Stowarzyszenie Przyjaciół i Absolwentów Zespołu Szkół Ekonomicznych, Aleja Józefa Piłsudskiego 5, 41-300 Dabrowa Gornicza, Poland,

represented by Michał Rabsztyn,

and

2. The Partner, Zemědělská akademie a Gymnázium Hořice– střední škola a vyšší odborná škola, příspěvková organizace, Riegrova 1403, Hořice, 50801, Czechia,

represented by Ing. Stanislav Neuman,

jointly referred to as Partners.

IMPLEMENTATION OF THE PROJECT

1 Partners agree that the Project shall last from 02/02/2026 to 31/08/2026 ("Implementation Period".)

2 Particular stages of implementation of the Project are specified in Attachment No.1 ("List of Events".) The Partners are obliged to maintain an up-to-date Calendar of Events. Any change in the dates, venues or types and names of events originally stipulated in the Calendar of Events must be updated and confirmed in the On-line System no later than 10 calendar days prior to the planned date.

3 The Partner shall immediately inform the Grantee in writing of any circumstance which may affect the realization of the Project or of any changes in contractual conditions.

4 All formal communication must be conducted in English.

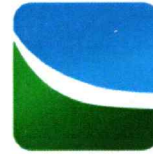
5 Partners are obliged to acknowledge the Fund's support of the Project

- on all premises where events take place as part of the Project (and visibly display the Fund's logo),
- in all printed materials distributed as part of the Project,
- in all public statements and presentations and
- on all web pages connected with the Project.

All acknowledgements must visibly carry the current version of the logo of the Fund and, if on-line, must be directly linked to www.visegradfund.org

Acknowledgements in event venues must be present for the duration of the events; acknowledgements online must remain active for the whole Contractual Period of the Project at a minimum.

6 The Partner shall take all steps to prepare and properly implement the agreed schedule of activities in accordance with this Contract and assumptions of the project:



- a. comply with the deadlines set out in Annex 1
- b. provide the Grantee with all documents necessary, such as invoices, participation lists, photographic documentation of events, tickets, etc.
- c. actively promote the Project, project activities through social media and visual display at school premises or venues of project implementation,
- d. agree on image dissemination in order to promote the Project and Project activities.

PROJECT GRANT

1 The 1st installment in the amount of E8,000.00 within 15 working days after the delivery of the valid and effective Contract by the Grantee to the Fund. The 2nd (and final) installment in the amount of E2,000.00 within 15 working days after the Final Report is approved by the Fund. The Final Instalment must be pre-financed by the Grantee and, if duly approved under conditions set forth, the Fund reimburses the due amount of the Final Instalment.

2 The Grant shall be used by the Partners only to cover the direct expenses of the Project during the Implementation Period of the Project, according to the List of Events which forms Attachment No. 1 hereof.

3 The expenses required for the Project from the Grant cannot exceed the approved amount.

4 The Grant may be used only during the contracted Implementation Period in an efficient and cost-effective way.

5 The Budget is constructed as a lump sum based on the number of direct participants and the number of days as detailed in the List of Events which forms Attachment No.1 hereof. In case the number of direct participants and/or the number of days is lower, the Fund reserves the right to lower the 2nd/Final instalment in the amount according to the Fund's rules set in the V4 Gen Guidelines and/or request the return of funds from the 1st instalment.

6 The Grantee shall cover expenses of the Partner connected with project implementation which have been agreed upon in advance, based on invoices presented. The original invoices shall be submitted to the Grantee and attached to the Final Report and Financial Statement.

7 The Fund reserves the right to determine the eligibility of each cost to be covered by the Fund. If the cost proves not eligible, the Partners must return/cover the proportional part of the Grant.

PERSONAL DATA PROCESSING

1 Partners agreed that they are obliged to comply with respective regulations related to personal data processing mainly according to Regulation (EU)2016/679 of the European Parliament and of the Council of April 27, 2016, on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation.)

2 The Contracting Parties agreed that obligation of the Fund resulting from Article 14 of the General Data Protection Regulation to all applicants/touched persons whose personal data shall be provided by the



Grantee to the Fund based on this Contract—to provide all applicants/touched persons with information about the processing of their personal data by the Fund will be carried by the Grantee. The Grantee is obliged mainly to provide all applicants/touched persons with written information on personal data processing on behalf of the Fund against the confirmation of the respective applicant/touched person together with receiving the application for the financial support (for example, Attachment 2)

FINAL PROVISIONS

1 This Contract shall enter into force on the day of its signing by both Partners. This Contract is concluded for a definite time period until 09/11/2026 (i.e., the implementation period +50 working days.)

Both Contracting Parties declare that they conclude this Contract of their free will, they have read its content and sign it as correct.

2 The Contract is drawn up in two identical copies in English. Each Partner shall receive one copy of the Contract.
