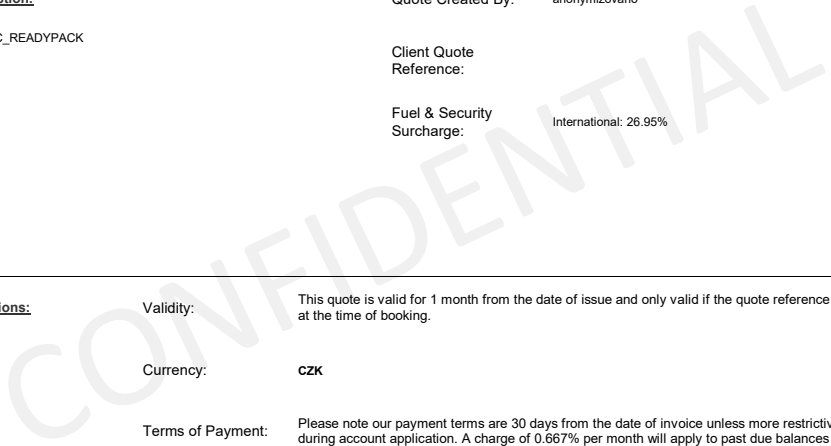

Dry ice shipments will be monitored and replenishments (if required) will be charged in addition to the quoted amounts. If at the time of shipping the volumetric weight is found to be greater than the actual weight, overweight and the tranship surcharge will be applied using the volumetric weight,  $v = (L \times W \times H) / 6000$  (for metric measurement systems) and  $v = (L \times W \times H) / 166$  (for imperial measurement systems).

The Fuel & Security surcharge is applied to the base, overweight, transship fee and driveaway charges only. This rate is reviewed on a quarterly basis & will be charged at the current rate at the time of shipping.

Additional surcharges may apply which shall be advised in advance. Taxes/VAT are not included in this quote. Taxes/VAT will be charged where applicable in line with current legislation.

Customs Taxes / Duty have not been included in this quote. Taxes/ Duty will be charged where applicable in line with declared Incoterms and in line with Local Legislation.

Any Customs Taxes / Duties will incur an advancement fee and reimbursed to World Courier on demand if first paid by World Courier.

Any applicable brokerage charges have not been included in this quotation unless specified. Any brokerage services performed by World Courier will be charged with rates available on request. If World Courier is invoiced by an external broker for this service then extra charges could apply in addition to this rate.
