We herewith order the following services related to implementation of awareness and communication related project output 1.3, specifically, we order the following services of Food Safety-related educational workshops for target groups of senior citizens and school students in Samegrelo and Imereti regions:

Deliverable 1: Preparation and plan of implementation

Date of delivery: 5.6. 2026

Description of service: The service provider will prepare the plan for implementation of the series of workshops for senior citizens (Deliverable 2) and a series of workshops for children and youth (Deliverable 3) in Samegrelo and Imereti regions, targeting also IDP population – in Khoni IDP settlement and in cooperation with Zugdidi Youth Centre.

Description of the deliverable 1:

1.1 Written plan of the workshops under activity 2 and activity 3, description of the selected partner institution (if applicable) and description of the participants' selection process.

Cost of the deliverable 1: 620 USD (According to Annex 1 to the service order)

Deliverable 2: Series of workshops for senior citizens

Date of delivery: 15.9.2026

Description of service: The service provider will organise a cycle of three workshops for the target group of senior citizens aged 65+, based on the methodology developed by Czech Development Agency (CzDA). Each workshop will last two hours and will additionally include a one-hour lunch break. Lunch will be provided by the service provider. Each workshop should be attended by at least 10 participants. The same participants are expected to take part in the full cycle of three meetings. In total, Deliverable 2 will target at least 10 unique beneficiaries. Full cycle of 3 meetings should take place preferably within the period of 1 or 1,5 months, with the minimum 1 week brake between two meetings.

Description of the deliverable 2:

2.1 Attendance lists (scan copy, according to the template provided by CzDA) and photo documentation from the workshops

2.2 Report with analysis of pre- and post-questionnaires (form of questionnaire is provided by CzDA) and analysis of oral feedback from the participants.

Cost of the deliverable 2: 2670 USD (According to Annex 1 to the service order)

Deliverable 3: Series of workshops for children of age 13-18

Date of delivery: 15.9.2026

Description of service: The service provider will conduct three workshops for children and youth aged 13-18, based on the methodology developed by CzDA. Each workshop will last 90 minutes. A small snack for participants will be provided by the service provider. Each workshop should be attended by at least 12 participants. In total, Deliverable 3 will target at least 20 unique beneficiaries.

Description of the deliverable 3:

3.1 Attendance lists (scan copy, according to the template provided by CzDA) and photo documentation from the workshops

3.2 Report with analysis of pre- and post-questionnaires (form of questionnaire is provided by CzDA) and analysis of oral feedback from the participants.

Cost of the deliverable 3: 831 USD (According to Annex 1 to the service order)

Deliverable 4: Reporting and handover of documentation

Date of delivery: 30.09.2026

Description of service: The service provider will submit the final narrative report on implemented services, including analysis of participants' feedback and pre-post questionnaires results (total 2-4 pages). The physical

copies (originals) of the attendance lists and pre-post questionnaires for all workshops under Delivery 2 and Delivery 3 should be delivered to the office of the Czech Development Agency in Tbilisi (Shalva Radiani street 9, 0179 Tbilisi, Georgia), and the electronic database of participants should be submitted according to the template provided by CzDA.
