


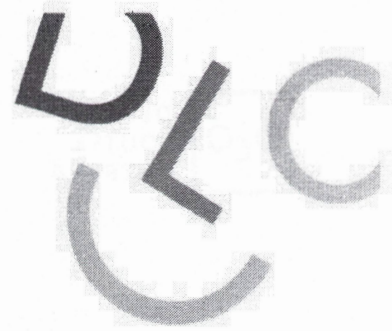
hereby conclude the following agreement:

#### ➤ Subject of the Agreement

- 1) The Guest shall perform for the Organizer **three** performances of the production **Draw Me a Human** within the Pimprléto 2026 festival on **19–20 July 2026** at the following times:  
July 19, 2026 at 10:00 a.m. and 6:00 p.m.  
July 20, 2026 at 5:00 p.m.
- 2) Venue: DLO Amphitheater, Divadlo loutek Ostrava, Pivovarská 3164/15, 728 32 Ostrava

#### ➤ Fee

- 1) The Organizer shall pay the Guest a fee in the amount of **EUR 1,600** on the basis of this agreement by bank transfer no later than July 31, 2026.
- 2) The Organizer shall not pay any copyright fees on behalf of the Guest.
- 3) In connection with the fulfilment under this agreement, the Organizer becomes an identified person pursuant to Section 6h of Act No. 235/2004 Coll., on VAT. DLO shall remit VAT in the amount of 21% from the above remuneration to the account of the Financial Office for the Moravian–Silesian Region, Ostrava I branch office.



➤ **Other Provisions**

- 1) The Organizer shall arrange and cover air transportation for 4 members of the ensemble in the amount of EUR 1,598 through the agency selected by the Guest: Travelpal Ltd. (ID No.: 202337833).
- 2) The Organizer shall provide the Guest with access to the amphitheatre from 8:00 a.m. and technical support for stage setup, lighting and sound as follows: Organizer's technical crew available from 8:00 a.m.

The exact working hours of the Organizer's lighting and technical staff may be further specified by mutual agreement.

- 3) The Organizer shall bear all operating costs related to the performances and shall provide services during the event including fire watch, ushers, stage manager, lighting and sound services.
- 4) The Organizer shall ensure adequate temperature in the dressing rooms and suitable dressing room facilities for the performers.
- 5) The Organizer shall independently arrange audience recruitment and ticket distribution. Information about the Guest and their performance shall be published by the Organizer on its website, on the *Pimpléto 2026* program poster and in the Organizer's Newsletter.
- 6) The Organizer undertakes to properly safeguard the Guest's property (musical instruments, etc.) against damage or theft during the period of the Guest's performances.
- 7) In the event of adverse weather conditions, the Organizer shall provide an alternative indoor venue protected from weather conditions.
- 8) The Organizer shall provide accommodation for 4 persons for the period from July 18 to July 22, 2026.
- 9) If the Guest cancels the performance after this Agreement has been concluded, the Guest shall reimburse the Organizer for all demonstrable costs incurred (e.g. ticket printing costs), up to a maximum amount equal to the agreed fee.
- 10) This Agreement and all legal relations arising from it shall be governed by the laws of the Czech Republic.
- 11) Pursuant to Section 89a of Act No. 99/1963 Coll., the Civil Procedure Code, as amended, the contracting parties agree that all disputes arising from or in connection with this Agreement shall be resolved by the competent court having jurisdiction according to the Organizer's registered office.
- 12) This Agreement is executed in two identical counterparts and shall enter into force on the date of signature by both parties.
- 13) The contracting parties may withdraw from this Agreement without entitlement to compensation only in the event of unforeseeable and unavoidable circumstances (e.g. natural disaster, government regulation, injury or illness of an artist), provided prior notice is given. In all other cases: if the Organizer cancels the performance more than 30 days before the scheduled



performance date, the Guest shall receive 50% of the agreed fee. If the Organizer cancels the performance less than 30 days before the scheduled performance date, the Guest shall receive 100% of the agreed fee.

- 14) The Guest acknowledges and agrees that pursuant to Sections 2(e) and 13 of Act No. 320/2001 Coll., on Financial Control in Public Administration and on Amendments to Certain Acts, as amended, the Guest is obliged to cooperate in the performance of financial control.
- 15) In accordance with Regulation No. 2018/13/03/0888 of the European Parliament and of the Council (EU) 2016/679 of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (GDPR), the Organizer is entitled to collect personal data concerning the Guest or natural persons acting on behalf of the Guest (i.e. data subjects) to the extent necessary for the proper conclusion of this Agreement, fulfillment of obligations arising from this Agreement and in connection therewith, including data serving to identify the data subject, bank details, registered office, company ID number, etc. The data subject has the right to information about what personal data concerning them is being processed and, should they determine that the processor has violated its obligations, they have the right to request remedial measures from the Office for Personal Data Protection. The data subject is entitled to request that the processor remedy the unlawful state and pay compensation for infringement of their right to human dignity, personal honor, good reputation and protection of their name.
