Whereas:

1. During the Contract performance by the Contractor the Contractor proposed to the Client a more advantageous technical solution related to the requirement No REQ-008007/A (Annex No 2 to the Contract) which will lead to a cost decrease as specified in Annex No 1 hereto. The Contractual parties hereby agree to the adjustment of the subject-matter of the Contract as specified in Annexes No 1 and 2 hereto and to the related change of the price of work (stipulated

by art X.1 of the Contract) according to the Annex No 1 to this Amendment.

Changes to the price of work shall be reflected in invoices related to the partial deliverables concerned.
