


## Performance Agreement

Public interest body Yokohama Arts Foundation (hereinafter to be called "A") and ALFA Theatre (hereinafter to be called "B") execute the Agreement concerning the performance as below:

A shall give performance as below under contract with B.  
This Agreement shall be executed in the Japanese language. Its English translation attached to the Japanese version is for reference only and shall not bind the parties herein.

1. Program Title : The special themed performance of the year of Czech Culture 2017  
"The World of Kihachiro Kawamoto" —Noh, Marionette and Puppet Animation"
2. Date : December 16(Sat) at 2:00 p.m. (One session in total)
3. Venue : Main Stage of Yokohama Noh Theater (27-2, Momijigaoka Nishi-ku Yokohama, Kanagawa, Japan)
4. Program : New work "Circus Trnka"(about 30 minutes)
5. Schedule in Japan  
December 13 (Wed) : Arrive in Japan  
December 14 & 15 (Tue & Fri): Set up & Rehearsal  
December 16 (Sat): Performance  
December 17 (Sun): Leave Japan
6. Inviting persons  

7. A shall pay to B the following amount in total as performance fee.  
Total: 4,021 US dollars (Inclusive of withholding income tax of 821 US dollars)
8. Payment Method  
A shall pay the amount of the performance fee of 3,200 US dollars by transferring to the following bank account, after the performance.

9. A shall pay the following expenses. Other expenses shall be paid by B.
  - ① Round-trip Airfare from Prague, Czech Republic, to Tokyo, Japan, and transportation expenses between airport and hotel in Japan.
  - ② Accommodation expenses for 5 persons from December 13 (Wed) - 17 (Sun) (Four nights) (Room charge, breakfast, service charge and tax only)
  - ③ Insurance covering the stay in Japan, provided, however, the details of insurance coverage shall be determined by A.
10. A shall be responsible for the followings:
  - ① Providing equipment and technical crew required for performance
  - ② Providing the box office report
  - ③ Providing complimentary tickets for the performance to the persons A accepts, provided that B should offer the guest list to A no later than November 30.
11. B shall be responsible for the followings:

12. B allows persons certified by A to record and make copy of the performance entirely or partially with picture, video, audio recording and any other means and broadcast and distribute them through news programs, TV or radio programs, or online etc.
13. In case either party does not perform this Agreement due to unreasonable reason, the other party may cancel this Agreement immediately and demand payment of penalty. The amount of penalty shall be equal to the contract money.
14. In case either party is unable to perform this Agreement due to force majeure events including natural disaster, war, civil commotion, strike or accident of public transportation means such as boat, airplane and railroad etc. government orders and administrative actions, A and B may renew or cancel this Agreement upon consultation.
15. In case of any problem arising from matters not stipulated in this Agreement, the parties shall discuss and settle the problem in good faith. Problems that cannot be settled through consultation shall be eventually settled by the exclusive jurisdiction by consent of the Yokohama District Court pursuant to the laws of Japan. Arbitrary award of the said jurisdiction shall be enforceable at any competent court.

IN WITNESS WHEREOF, the parties have caused this Agreement to be signed and sealed in duplicate, each party holding one copy thereof.
