1. The Bidder

HaskoningDHV Czech Republic, Ltd. is the Czech subsidiary of an independent international engineering and project management consultancy company Royal HaskonigDHV (Netherlands). The Czech subsidiary, as well as the whole company, is committed to deliver added value for its clients while at the same time addressing the challenges societies across the world are facing today – in respect of cities, water, transport and industry. The company as whole as well as its Czech subsidiary provide consultancy and engineering services to clients from both, private as well as public sectors.

HaskoningDHV CZ, formerly known as DHV CR, has been working in Central Europe since 1992, when it was incorporated in trade register in Prague, Czech Republic. Its approximate annual budget is 1 330 000 EUR.

As a multidisciplinary planning and engineering consultancy, the HaskoningDHV Czech Republic is regarded as being one of the leaders in integrated urban and regional planning in the Czech Republic and Central Europe. Key clients are mainly public sector authorities such as: statutory cities, major cities, regional governments, central governmental ministries, governmental trade and development agencies Czech Invest and Czech Development Agency and many others. Requests are received for company's expertise as a co-operation partner as well as lead partner for projects financed from international sources (USAID, UNDP, European Union, EIB, World Bank and EBRD). In the international scope company experts from the Czech Republic work in large internationally funded projects particularly in post-Soviet territory and Western Balkan countries. In the last five years there were five projects for three different clients implemented in Moldova, ranging from ca 20 to over 110 thousands USD (the clients being Czech Development Agency, EBRD and Ministry of Foreign Affairs of the Czech Republic). Two of these major projects were focused at provision of consultancy and methodological support and Capacity Building explicitly in Development Region South (including organization of Study Trips to the Czech Republic). First of these projects had twofold aims: support to elaboration of the Regional Development Agency as well as the members of Regional Development Council (i.e. representatives of regional and local councils form the region South) in Strategic Planning. The second project went few steps further



and aimed at creation of sufficient capacities at regional and local levels to implement the strategies. Most imporatently it was aimed at encouraging local economic development by investing into business infrastructure and initiating cooperation between public and private subjects as well as associating private subjects (e.g. shared processing centres, business incubators, etc.). Over one and half years' time we held series of seminars in every rayon (attended by regional / local politicians as well as public officers) aimed at development of local economic development projects and their implementation. Key experts who were involved in all of the projects in Moldova, especially the ones in the South Region (including rayon Taraclia) are holding key positions in our team for this project. Within the last two years we have organized two study trips to Czech Republic (as parts of two different projects) which were, partly, aimed also at business infrastructure, public-private a private business associations (e.g. in tourism, development of local brands, etc.). The topic of business associations in agriculture was also a part of yet another project that we have held in Moldova that was focused on evaluation of interventions in support to establishment of agriculture cooperatives.

5. Initial implementation plan

Since the time scope of the project is fairly limited, high level of cooperation with the partner institution, RDA North, as well as clear plan of action are essential to the success of the project. We have been cooperating with RDA very intensively for the last 3 years, therefore, we can begin with the implementation without further delay that would otherwise be caused by getting to know the context, people at the agency, their capacities and capabilities, clarifications of expectations and different points of view on the subject of this tender, etc. We are also aware of data availabilities, its relevance as well as limitations and gaps – therefore, we do not need much extra time for identification of databases, studying the sources, etc. All of these preconditions are vital should the first draft of the outcome, namely the strategy and action plan of regional specialization, indeed be delivered before 8th December 2017.

Also it should be noted, that the work will not be starting from scratch. RDA has already spent significant time and resources on formulation of their initial thoughts and points of view regarding regional specialization. We will, therefore, start our work from this point, verify and, if necessary, update materials that are already elabortated and then analyze the matter into greater depth.

Plan of action:

a/b)Before first mission.

We would like to organize the first mission as soon as possible. The most fitting dates for the first mission are $13^{th} - 17^{th}$ November. Therefore, the time before the first mission is relatively short: one week. In this time we will realize the following:

- Start communication with RDA North and acquire all relevant documents;
- Elaboration of detailed programme of first mission, in collaboration with RDA, and submission of this programme to CzDA;
- Review existing databases used in RDA North documents and review the Statistical Yearbook of the Statistical Office of Moldova in order to identify other relevant indicators;
- Identify key stakeholders and discuss their list with RDA North;
- Organize appointments with key stakeholders for interviews, with logistical support of RDA North;
- Discuss capacities of RDA North that could be made available for us during first mission;
- Elaborate methodological and guidance documents (such as interview guides).
- c) First mission.

As noted above, we would like to organize first mission as soon as possible in order to gain maximum available time for the elaboration of Strategy and action plan. Sicne we know the "landscape" of Region North, we are confident that proparation time can be limited to minimum. Therefore, our proposal is to organize first mission between 13th and 17th November.

The mission will be carried out by Radim Gill. We also presume that at least one specialist of RDA will be made available for us during the whole first mission in order to raise the efficiency of implemented activities.



It is our understanding that we will not need too much time for collection of statistical data during the mission. This will be, to a large extent, done before the mission and will be followed-up by email communication after the mission. We would, therefore, like to spend as much time on the mission as possible with collection of primary data. This will be done predominantly by the means of individual interviews. Interviews will be realized with representatives of the following institutions:

- Public institutions rayonal and municipal level
- Representatives of businesses and their associations
- Representatives of relevant NGOs, such as ProBusiness North and other
- Representatives of other projects and intervention schemes relevant to this field (most importantly regional representatives of GIZ and new project implemented with the support of CzDA by People in Need)
- Representatives of University of Balti

Our initial plan is to spend cca 3 days with field research (Tuesday – Thursday). For that purpose we will also reach outside Balti, it is our intention to spend two days in the region (e.g. Edinet+Drochia or Drochia+Soroca in one day and Falesti+Sangerei or Sangerei+Floresti in the other). First day of the mission will be spent in Balti – mainly on ADR working on structure and contents of the Strategy. Last day will be again spent in Balti. If possible, we would like to organize a workshop on the last day of our mission, during which the initial conclusions and findings would be discussed and verified.

It is our intention to work closesly with at least one representative of ADR North throughout the whole week. Such measure would enable us to double the number of stakeholders to which we reach out.

Details of first mission will be elaborated upon in the programme of the mission that will be submitted to CzDA before departure.

d/e)A report of the first mission will be elaborated and sento CzDA within few days after the mission. The report will summarize implemented activities and most importantly realized meetings. It will nto contain minutes of individual interviews as those are considered confidential.

Based on discussions with ADR and reached agreement also the structure of the Strategy will be elaborated and presented to CzDA within max. 10 days after return from the first mission.

f) Th initial draft of the Strategy and action plan will be elaborated until 8th December 2017. The document will follow agreed structure and will be based on data an information collected during the mission as well as desk research by project team members and by RDA staff. We expect RDA to assist us with identification of additional and supporting indicators / data sources also after the first mission, should a need of deeper investigation of selected trend arise.

Draft of the Strategy and action plan will not be a mere summarization of collected data / information. Moreover, an expert opinion of team members will be added with regard to feasibility and relevance of the document. It should be noted that team members were part of elaboration of a number of overall / sectoral startegies in Moldova, including



Region North and they also know Region North very well. Therefore, their expert inputs is a relevant source of information and presents the added value of our approach.

Implementation plan will be part of the Strategy and action plan. The implementation plan will elaborate in details what are the specific steps necessary to fulfill the Strategy. Also a monitoring system will be suggested – one that is in line with monitoring / reporting systems of other strategic documents at ADR in order to incorporate the implementation of the Regional specialization strategy into regional development activities as whole that are realized by ADR

The draft document will be at least 35 pages long. It will be presented to CzDA until 8th December. Once comments from the CzDA will have been received, these will be processed within 3 days.

- g) Second field mission is foreseen for late January 2018, however, dates will be specified in the programme of second mission. Second mission will focus on finalization of the Strategy and action plan and on the assessment of Regional Brand(s) potential in the region. For that purpose, a number of individual interviews with relevant stakeholders will again be planned, with the support of RDA. The subjects of these interviews will be local producers, entrepreneurs in tourism (hotels, restaurants), local business and tourism associations, University of Balti and independent experts. List of stakeholders to be approached will be elaborated uon in the programme of second mission that will be presented to CzDA at least 5 days before departure. Eventual comments will be processed within 3 days.
- h) Second mission is foreseen for late January or early February 2018. On the basis of initial research (stakeholder analysis) and reaching out to the stakeholders (support of RDA staff is expected in this regard), the mission will last 4-5 days.

Lukas Malac and Jakub Hlavacek will take part on the mission. Lukas will focus on discussions around elaborated Strategy and action plan and its finalization. Jakub will focus on ativities in the field of regional branding.

 A report of the second mission will be elaborated and sento CzDA within few days after the mission. The report will summarize implemented activities and most importantly realized meetings. It will not contain minutes of individual interviews as those are considered confidential.

Final outcomes (Strategy and action plan regarding regional specialization, report regarding the potentials of regional branding) will be delivered to CzDA by the latest on 28th February. Eventual comments of CzDA will be processed within 3 days.

j) Final outputs will be handed over to RDA in electronic as well as hard copy. Translation of final outputs is not part of the scope of this project.
