

**ADDENDUM TO  
TELEVISION  
FORMAT LICENSE AGREEMENT**

**DATE:** 7<sup>th</sup> December 2017

**PARTIES:**

1. **ENDEMOL SHINE IP B.V.**, (formerly known as Endemol Shine Group B.V.) a private limited liability company (besloten vennootschap met beperkte aansprakelijkheid) incorporated under the laws of the Netherlands, (registered with the Dutch Chamber of Commerce under number: 32057315 with corporate seat in Hilversum, the Netherlands) (Company VAT number: NL 8010.35.211 B01) and trading address at MediArena 1, 1114 BC Amsterdam - Duivendrecht, The Netherlands (hereinafter "**Licensor**").

and

2. **ČESKÁ TELEVIZE (CZECH TELEVISION)** (Company ID number: 00027383, VAT: CZ00027383) a company organised and existing under the laws of Czech Republic whose registered office is at Kavčí hory, Na Hřebenech II 1132/4, 140 70 Praha 4, Czech Republic in this matter duly represented by Petr Dvořák, General Director (hereinafter "**Licensee**").

Hereinafter jointly referred to as "**Parties**" or individually as "**Party**".

**CONSIDER THAT:**

- A. The Parties entered into a Television Format License Agreement for [REDACTED] (the "**Format**"), on 25<sup>th</sup> April 2017 under which the Licensee was granted rights to produce and broadcast a third Series of the Format (the "**Agreement**"); and
- B. The Licensee now wishes to exercise to licence rights for [REDACTED] (the "**Specials**") and the Licensor wishes to grant to the Licensee, the right to produce and exploit the Specials in the Territory (as defined in the Agreement) on and subject to the terms set out in this addendum (the "**Addendum**").

**THE PARTIES NOW AGREE AS FOLLOWS:**

1. The Licensor hereby grants to the Licensee the Rights Granted in the Territory during the Term (each as defined and out in the Deal Memo part of the Agreement) in the Specials on the terms and conditions set out in the Agreement and subject to the specific terms agreed for each further Series set out in this Addendum.
2. The Specials shall be:
  - (i) a total of [REDACTED] Episodes, each with a duration of [REDACTED]
  - (ii) intended for [REDACTED], with first exercise of the Basic Broadcast Rights to be undertaken as [REDACTED] exact broadcast schedule to be provided to Licensor in advance as soon as confirmed.

3. Fees

3.1 The Format Fees (per Episode) is:

3.2 The additional Total Fee due in respect of the Specials is:

€6,000 (six thousand Euros) exclusive of all taxes and withholdings of any kind, being €6,315.78 (six thousand three hundred and fifteen Euros and seventy eight cents) inclusive of withholding tax at a rate of 5% (the "Specials Fee").

3.3 The Specials Fee shall be due payable [REDACTED] and in any event by [REDACTED] in accordance with the payment terms and conditions set out in the Agreement.

4. References in the Agreement to Episode(s) shall be interpreted to mean either the standard episodes the duration, fees and transmission schedule are as set out in the Agreement, or the Specials, individually (and separately) or collectively as appropriate in the context.

5. MISCELLANEOUS

5.1 All other terms of the Agreement shall remain in full force and effect. In the event of any inconsistency between the Agreement and the terms of this Addendum, the terms of this Addendum shall prevail. Any capitalised terms used in this Addendum and not defined, shall have the meanings ascribed to them in the Agreement.

5.2 This Addendum shall be governed by and construed in accordance with the laws of The Netherlands.
