4 General Provisions

4.1 Terms of Payment

Our invoices are due 30 days net counted from delivery of the invoice to IOCB. Late payment will be charged a penalty of 5 percentage points on Deutsche Bank Fixed Base Interest Rate per commenced month.

4.2 Terms of Delivery

The delivery of the final report (including all experimental procedures and analytics) and achieved compounds will be conducted after finalizing the project within the agreed time frame.

4.3 Delivery Method

Taros Chemicals will ship finished compounds by either carrier DHL, UPS or GLS. Taros charges a shipping and handling fee lump sum of 40 € for national destinations and 100 Euros of international destinations. If, upon the request of an authorized representative of IOCB additional partial shipments are to be carried out, deliveries will be charged according to the conditions of this paragraph. Prices exclude VAT.

4.4 Miscellaneous

Biweekly up-dates will be given by e-mail and/or telephone conferences. The project will start with a kick-off meeting that will clarify contact details of all participants and any other issues before start of project.

Unless otherwise agreed in writing, Intellectual property (IP) (inventions, discoveries, results or data) arising as a result of the services performed by Taros as described in this Agreement shall be the sole property of IOCB upon full payment of all fees and expenses due under the ordered service.
