# Subject of agreement

The theatre will play 1 performance of "Pomnik", in the program of the 33<sup>rd</sup> SKUPA'S PILSEN festival in Pilsen, Czech Republic.

### IV. Payment

- The festival will pay the performer a NETTO sum of 2.000 EUR for 1 performance.
  The fee brutto 2.353 EUR (subject to 15% withholding tax = 353,- EUR) netto 2.000 EUR
- 2. The festival furthermore undertakes to provide at its own expense the following for the performer:
  - a) Traveling expenses and other costs, of 1500. EUR
- 3. The total sum of 3.500,- EUR (according to IV./1 2) will be made by bank transfer, NETTO of all taxes upon the invoice relatived from the performer after the performance on June  $14^{th}$ .

# Other obligations of festival

1. The festival will provide accommodation according to a rooming list (annex 1) of the performer for 17 members for 2 nights 13.06-15.06.2018.

## **Technical rider**

The technical conditions will be provided according to the technical requirements of the theatre, which are specified in annex 2 of this contract.

# VII. Others

- 1. If the performance as described in part I. does not take place due to the performer fault there will be no claim for the fee and related cost. In this case the performer must pay to the festival the expenses provably spent for the realization of the performance.
- 2. If the performance as described in part I. does not take place due to the festival fault then the fee and related cost will be paid.
- 3. Both parties have right to terminate the contract in case of an unpredictable event, caused by force majeure (fire, flood, war, national calamity, mourning, epidemic, strikes, lockouts, etc.). In such case they will compensate each other for services rendered so far and will not seek further compensation.
- 4. Both sides agree that this performance is presented on the base of cooperation between festival and theatre, so in case of any disputes both parties will have right to seek compensation for documented payments. The validity of this contract will be established only after signature of both parts.
