I.

Subject of agreement

The group will play 2 performances of "Paradise", in program of the festival the 33rd SKUPA'S PILSEN in Pilsen, Czech Republic.

II.

The date of the performances

The performance will take place:

- 15th June at 20:00 and 16th June at 15:30 in Alfa Theatre, Rehearsal spa<mark>ce,</mark> Rokycanská 7, 312 00, Pilsen.

The stage set-up will start on 15^{th} June at 17:30 , strike down 16^{th} June 16:30 – 17:30.

III.

Place of the performance

IV.Payment

- 1. The festival will pay the performer a **NETTO** sum of **3.200 EUR** for 2 performance. The fee brutto 3765 EUR (subject to 15% withholding tax = 565,- EUR netto).

- 1. If the performance/s as described in part I. do not take place due to the performer fault there will be no claim for the fee and related cost. In this case the performer must pay to the festival the expenses provably spent for the realization of the performance/s.
- 2. If the performance/s as described in part I. does not take place due to festival fault there the fee and related cost will be paid.
- 3. If partial acceptable performances are delivered the fee will be reduced accordingly.
- 4. Both sides agree that this performance/s is/are presented on the base of cooperation between festival and group, so any will present a claim on any others payments. The validity of this contract will be established only after signature of both parts.
