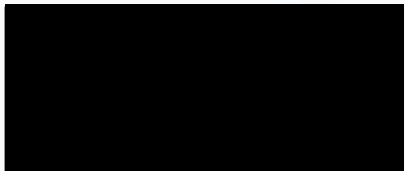
1 INTERPRETATION
