



## **PERFORMANCE CONTRACT**

### **The Promoter:**

hereinafter named respectively as «Promoter» and «Group», it is agreed that:

1. The Group, composed of n. 4 artists agrees to appear as known for 2 performances. The chambre concert Boi Akih to be held **on July 31 2018** in Namest nad Oslavou (Czech Republic). The group agrees to participate on the project Three Percussions and Voices (August 1 –3), performance to be held **on August 3 2018** as a part of the Folk Holidays festival 2018.
2. For the above mentioned performance, the Promoter grants the Group a fee corresponding to the total amount of **2 920 EUR**, net of any taxes (1 000 EUR for chambre concert, 1 920 EUR for participation on the project).
3. The Promoter will arrange and pay, in addition, local transfer from Krems to Namest and from Namest to Vienna for 5 persons on days of arrival (July 30) and departure (August 4).  
*Special catering requests: No porc and organic meat*
4. The Promoter will arrange, in addition, catering and accommodation for 5 persons in hotel (5 nights, 1 x double room, 3x single room on days of the stay (July 30 – August 4)
5. The Promoter will effect the payment of the sum here above mentioned (point n. 2) as follows: **Payment will be done via Banktransfer in two times.**
  1. On **June 30 2018** - 50% **€1460** (one thousand four hundred and sixty euros)
  2. On **August 4 2018** - 50% **€1460** (one thousand four hundred and sixty euros)
