1. The Prague Zoo puts at the disposal of the Recipient the following animal for breeding and for associated display purposes:

(Hereinafter referred to as the Animal)

- **2.** The Animal will be transported by June 30, 2018.
- 3. The Prague Zoo confirms that it is the owner of the Animal.
- **4.** The Recipient is required to cover all transport costs.
- 5. The Animal will belong to the Recipient after delivery.
- 6. The Prague Zoo provides no warranty as to the health of the Animal. The Prague Zoo assures that it is not aware of the Animal's having any diseases or contagious diseases. The Animal will be delivered in a good state of health, without any clinical symptoms of disease.
- **7.** The Recipient is required to inform the Prague Zoo of all requirements of the relevant authorities to import the Animal to the country/region of its residence.
- 8. The Animal will be delivered with a valid Certificate of Health and Origin and other documents respecting all requirements given by the exporting country and by the importing country as reported by the Recipient (see Point 6).
- **9.** Because these Animal belongs to an EEP species, the transfer and all future transfers must be allowed by the program coordinator and both the owner as well as the receiving institution agrees to follow its recommendations regarding the given Animal.
- **10.** The Recipient is required to ensure the Animal with adequate housing, diet, veterinary care and other necessities conducive to the well-being of the Animal.
- **11.** Upon delivery of the Animal, a hand-over certificate will be ratified. The Recipient will scan the signed hand-over certificate and will send it via e-mail to the Prague Zoo within 24 hours / will hand it to the Prague Zoo representative at place.

2. Two originals of this agreement are executed, one for each Party.



- **13.** Any difference or dispute arising out of the interpretation and/or implementation of this Agreement shall be settled amicably through consultation and/or negotiations between the parties.
- 14. Rights and obligations of the parties that are not explicitly defined in this agreement shall be governed by relevant provision of the Civil Code of the Czech Republic. While this agreement has been executed in English, it is subject to the laws of the Czech Republic only.
- **15.** The Recipient acknowledges that the Prague Zoo is bound by the Act No. 340/2015, Register of contracts, and agrees that the text of this contract/ appendix and concerned contract will be published through the Prague Zoo in Register of contracts.
- **16.** The Contracting Parties agree with publication of this agreement in its entirety including personal data contained in the contract, as well as of the acts and circumstances associated with this agreement, or with provision of information to third parties about this agreement or the essential parts of this agreement, under the conditions defined in Act No. 106/1999, free access to information, in the version current at the date of request for information or publication, and also declare that none of the contents of the contract shall not be considered as trade secret.
- 17. The Recipient declares that none of the content of this contract/ appendix and concerned contract does not consider as trade secret, and also agrees with publication of the personal data included in the contract/ appendix and concerned contract.
