In accordance with a mutual desire to promote international academic, cultural and scientific exchange, University of Malaya (UM) and the University of Chemistry and Technology, Prague (UCT Prague), have agreed to cooperate within the framework of the principles mentioned below.

I.

Scientific and educational cooperation shall be undertaken in areas of mutual interest. Such cooperation will be carried out on the basis of equal and mutual advantage.

II.

The cooperation between UM and UCT Prague will be implemented in the following ways:

- Exchange of graduate and postgraduate students (Master and PhD students);
- Exchange of teachers for short term teaching assignments;
- Agreements on double degree programs;
- Joint supervision of a doctorate;
- Development of joint research programs;
- Organization of the bilateral joint symposiums, seminars and conferences.

III.

Each University shall ensure, in compliance with its respective laws and regulations, the assistance and support for scholars who are temporarily residing on its territory, under the provision of this Memorandum.

IV.

This Memorandum does not result in any financial obligations. Each University will be responsible for seeking funds to support its involvement in the cooperative activities contemplated under this Memorandum of Understanding, and all such activities will be dependent upon the budgetary appropriations of the Universities.

V.

The terms of cooperation for each activity implemented under this Memorandum shall be mutually discussed and agreed upon by both Universities in a separate written agreement prior to the initiation of that activity. Any such agreement entered into, as outlined above, will form an Appendix to this Memorandum.

VI.

Participants have to fulfil all the conditions required by the immigration authority of the host country.

VII.

The present Memorandum was prepared in English in two copies. Both of them have the same legal power.

VIII.

- This Memorandum will enter into effect from the date duly signed by the designated officials of the respective Universities. The effective period is five years and may be extended for such further period as may be agreed by the Universities in writing.
- Notwithstanding the abovementioned, should either University wish to terminate this Memorandum, a written notice should be given three months in advance of the desired termination date.
- This Memorandum may be modified, varied or amended at any time after due consultation and with the written agreement of both Universities.
- This Memorandum is not intended to be legally binding. It merely expresses the intentions and understanding of the Universities which will form the basis of any legally binding agreement to be drafted and executed in the future.
- Both Universities hereby agree that they are not bound exclusively by this Memorandum and shall be at liberty to enter into any separate agreements or arrangements with any third party without reference to the other University.
- Both Universities agree and undertake to keep confidential at all times any information or data that may be exchanged, acquired or shared in connection with any programme or activity conducted pursuant to this Memorandum save where the same is already in public domain.
- Any use of the names of 'University of Malaya' or 'University of Chemistry and Technology, Prague', including any of its constituent schools, departments, programmes, logos or official emblem, relating in any way to the activities described in this Memorandum, shall be subject to prior written approval.

IX.

Every notice, request or any other communication required or permitted to be given pursuant to this Memorandum shall be in writing, in English and delivered personally or sent by registered or certified post via air mail or by courier or facsimile (which shall be acknowledged by the other University) to the Universities at the address and facsimile number as stated below:
