This License Agreement for Nonprofit Research Institutes ("Agreement") is between the licensee printed below ("**Licensee**"); **Environmental Systems Research Institute, Inc. ("Esri")**, as licensor of the Products licensed under this Agreement; and the distributor listed below ("**Distributor**"). The Distributor is authorized by Esri to provide access to Online Services, distribute updates, and provide technical support for said Products and other benefits to Licensee as described in Distributor's most current applicable support services policy. The Agreement includes this signature page and the License Agreement. License agreement means the applicable license agreement incorporated by this reference that is (i) found at <http://www.esri.com/legal/software-license>, is composed of the General License Terms and Conditions (E204) and Exhibit 1—Scope of Use (E300), and is available in the installation process requiring acceptance by electronic acknowledgement or (ii) a signed license agreement between Esri, Distributor (if applicable), and Licensee that supersedes such electronically acknowledged license agreement. The Parties acknowledge that they have read and understood this Agreement and agree to be bound by the terms and conditions hereof as applicable to each Party.

This Agreement is only available to research institutes that are not for profit and shall solely use the Products for research purposes that are noncommercial in nature. Licensee hereby represents that Licensee meets the qualifications listed in this paragraph and agrees to comply with the terms and conditions of this Agreement.

The General License Terms and Conditions are modified by the addition of the following restrictions on use and access:

1. Licensee may only use Products and access Online Services within the country where Products were ordered;
2. Licensee may use Products and access Online Services solely for research purposes in support of government activities that are noncommercial in nature.
3. Licensee shall not use the Products for (i) projects generating profit, (ii) provision of goods or services that compete with those of commercial companies, or (iii) any commercial or profit-generating activities.

This Agreement may be executed in duplicate by the Parties. An executed Agreement, modification, amendment, or separate signature page shall constitute a duplicate if it is transmitted through electronic means, such as fax or e-mail, and reflects the signing of the document by any Party. This Agreement constitutes the sole and entire agreement of the parties as to the subject matter set forth herein and supersedes any previous agreements, understandings, and arrangements between the Parties relating to such subject matter. Any modification(s) or amendment(s) to this Agreement must be in writing and signed by an authorized representative of each Party.
