### **AMENDMENT No. 1 to the Contract for Provision of Telecommunication Services**

### **WHEREAS**

- (1) SITA and LP entered into a **Contract for Provision of Telecommunication Services** dated 12 April 2007 ("the Agreement"),
- (2) Client has requested, and SITA has agreed, pursuant to the terms and conditions of the Agreement and this Amendment No. 1:
  - (a) to continue providing the Services specified within the Agreement;
  - (b) to upgrade existing IPVPN connection from 128 Kbps to 512 Kbps;
  - (c) To order new IP port for CUTE connection;

NOW, THEREFORE, the parties agree as follows:

## **Article 1: Definitions**

Except as otherwise defined herein, the terms used herein shall have the meanings given to them in and by the Agreement (including its Amendments).

# **Article 2: Term**

This Amendment No. 1 shall commence upon signature by both parties and shall be coterminous with the Agreement.

### Article 3: Scope of Amendment No. 1

- 3.1 The Client requires and Contractor shall provide upgrade of existing IPVPN connection from 128 Kbps to 512 Kbps and deliver one new IP port for CUTE connection in accordance to Annex.1 of this Amendment (APH Service Request form).
- 3.2 SITA undertakes to commence the delivery date of the additionally ordered Services described in article 3.1 of this Amendment No. 1, at latest, within the period of 8 weeks from the date of signing of this Amendment No. 1 by both parties.

## Article 4: Financial Terms of Amendment No. 1

- 4.2 For the avoidance of doubt, with effect from the date of signing of this Amendment No.1 by both party, the Annex No. 2 of the Agreement is replaced by the following:
