



AGREEMENT OF COOPERATION № _____

between

**Kyiv National Economic University named after Vadym Hetman,
Institute of Information Technologies in Economics (Kyiv, Ukraine)**

and

**Brno University of Technology,
Faculty of Business and Management (Brno, Czech Republic)**

Kyiv National Economic University named after Vadym Hetman, Institute of Information Technologies in Economics (Kyiv, Ukraine) and Brno University of Technology, Faculty of Business and Management (Brno, Czech Republic) hereinafter called “the contracting parties”,

- considering that cooperation between countries in the field of higher education has great influence on the preparing and development of high level human recourses, which are a basic of socio-economic and cultural development;
- emphasizing that all universities and other academic institutions have goal to improve their positions in the field of education and preparation of specialists by mutually reinforcing their teaching, training and research capacities, by sharing recourses and by undertaking joint activities, based on equal partnership;
- with confidence of the fact that increased academic cooperation can make an important contribution to better understanding, expansion of a spirit of mutual respect, trust and friendship among peoples of different countries and regions have concluded the present Agreement as follows:

ARTICLE 1

The contracting parties believe that it is expedient to determine the following main directions of cooperation:

- perfection of the teaching process;
- methodological support of the teaching process;
- advanced professional training of teachers and other staff;
- carrying out of joint scientific research in the field of economics, management, information technologies, industrial systems organization and in other directions of the contracting parties’;
- providing of cultural exchange;
- taking measures for adaptation of the educational programs used in partner Institutions;
- information exchange in the field of education and particularly new methods of education and also providing scientific, practical seminars, conferences, symposiums, seminars etc.;
- mutual informing of the sides, organization and participation in providing scientific and practical conferences, symposiums, seminars etc.;
- realization of joint commercial projects;
- participating in national and international educational programs and projects;
- organization of joint projects in the field of post-graduate and additional education including post post-graduate education and advanced training;
- realization of joint publications, scientific, educational and methodological works.

ARTICLE 2

The contracting parties will exchange of students for internship studies on agreed programs at partner Institutions, for field work in enterprises and also for studies and advanced training.

ARTICLE 3

The contracting parties foresee the transfer of teaching and methodological materials for study and use, and joint development of new teaching and methodological materials, study books, business games, general educational programs.

ARTICLE 4

Organization of videoconferences for distance learning education including forms of open education and also providing of scientific and practical conferences, symposiums, meetings etc is foreseen.

ARTICLE 5

The contracting parties will interchange teachers and other staff for lecturing and experience exchange according to the curriculums of the Institutions, organizing of teachers' training, summer schools for students and doctoral students.

ARTICLE 6

The contracting parties will execute joint research and development in the fields of economics, industrial organization, marketing, management, information technologies (including telematics, logistics etc.). The parties envisage publishing the results of the research in the form of separate publications or in collections of scientific work issued by Institutions.

ARTICLE 7

The contracting parties will invite each other's representatives to participate in major and representing mutual interest of partner Institutions conferences, symposiums, meetings etc.

ARTICLE 8

The contracting parties will jointly make working programs of their main activities for each year to specify forms and terms of cooperation.

ARTICLE 9

The financial issues of cooperation will be agreed while making the working program or for any activity needing financial expenditure.

ARTICLE 10

In the course of realization of the present Agreement the partners nominate coordinators from Czech and Ukrainian sides. The corresponding letters notify this fact.

ARTICLE 11

In the course of coordination of their activity on fulfillment of the present Agreement the parties consider that it is expedient to organize working meeting not less than once a year.

ARTICLE 12

The present Agreement comes into force from the day of its signing by both parties and is valid during five years. At the end of 5-years period the agreement will be automatically prolonged if any part doesn't announce the opposite in the terms of 3 months before ending of Agreement.

ARTICLE 13

The present Agreement does not infringe on the contracting parties' rights toward the third parties.

ARTICLE 14

The present Agreement is made in 2 copies in English, each copy consists of 3 pages and has equally juridical value.
