Article I

Aim and purpose of the Memorandum

In recognition of their shared interest in establishing and developing a cooperative relationship between the two above-mentioned organisations, and within their respective powers, hereby agree that:

1. The aim of this document is to establish and develop the relationship between the University and the VSCHT, to establish a program of exchange and collaboration in areas of interest and benefit for both institutions within the Project below specified.
2. The UPOL and the VSCHT will cooperate in Technology Transfer/Research Commercialisation.
3. This document is intended to facilitate inter-institution cooperation through the following activities:
 - a. exchange of information and specific commercial expertise and experience relating to commercialisation projects
 - b. sharing of industry contacts and intelligence as they relate to specific projects or general areas of research collaboration
 - c. hosting short visits of commercialisation managers, targeted at advancing specific project(s) at times to be mutually agreed.

Article II

Confidentiality

In order to put this Memorandum into effect it may be necessary for one or both of the organisations to disclose confidential information to the other. The organisation receiving such information (Recipient) shall keep all Confidential Information imparted to it in confidence confidential and will not, without the prior written consent of the organisation disclosing such confidential information (Discloser), disclose said Confidential Information to any person or entity, except those of Recipient's officers or employees who require said Confidential Information for carrying out the objectives of this Memorandum. Recipient shall not be entitled to disclose Confidential Information supplied by Discloser to third parties for any purpose without the prior written approval of Discloser.

Article III
Intellectual property

1. No activity undertaken under this Memorandum shall affect the ownership of or grant any rights under existing, background Intellectual Property
2. Any Intellectual Property generated during activity anticipated by this Memorandum of Understanding shall be owned by the organisation generating it.

Article IV
Duration of the Memorandum


1. This memorandum shall be in force for a period of 3 years from the date of the last signing, and is subject to revision or modification by mutual agreement.
2. Either institution may terminate the memorandum at any time, although such action will only be taken after mutual consultation in order to minimise, if possible, any inconvenience to either organisation.

Article V
Final provisions


1. This memorandum is effective when the representatives from each organisation have affixed their signatures to the agreement.
2. This memorandum may be changed or altered only by written numbered amendments signed by both Organisations.
3. This Memorandum is intended to be non-binding on the Parties, except for the obligations under Article II, Confidentiality

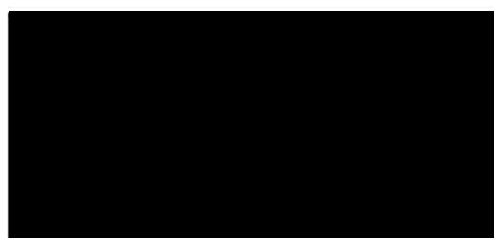
