Both Parties hereby agree with publication of this Agreement and Supplemental Agreements in the register of contracts with the exception of the facts that constitute trade secrets.). Parties hereby declare, that facts contained in this Agreement regarding all prices and discounts, identification of managed Aircrafts and penalties are considered trade secrets regarding § 504 Act No. 89/2012 Coll., Civil Code.”
