AMENDMENT Reference No AMD-648509-2

Grant Agreement number: 648509 — Large Discrete Structures (LaDIST)

The parties agree to amend the Grant Agreement as follows ('Amendment'):

1. Addition of a new beneficiary

The following new beneficiary is added:

- UNIWERSYTET JAGIELLONSKI (Jagiellonian) — as from 1 September 2018

This implies the **following changes** to the Grant Agreement:

- The grant becomes a multi-beneficiary grant and the Preamble and all the Articles are adapted to the multi-beneficiary version of the grant agreement.
- The new beneficiary and the 'accession date' is added to the **Preamble**:

 "UNIWERSYTET JAGIELLONSKI (Jagiellonian), 000001270, established in Ul. Golebia 24, KRAKOW 31007, Poland, PL6750002236 as from 1 September 2018"

2. Change of Annex 1 (description of the action)

Annex 1 is changed and replaced by the Annex 1 attached to this Amendment.

3. Change of the reporting periods

The financial reporting periods are changed.

This implies the **following changes** to the Grant Agreement:

- The 'financial reporting periods' in **Article 20.3** are replaced by:
 - " FRP 1: from month 1 to month 18
 - FRP 2: from month 19 to month 33
 - FRP 3: from month 34 to month 51
 - FRP 4: from month 52 to month 60"

4. Changes of Annex 2 (estimated budget of the action)

Annex 2 is changed and replaced by the Annex 2 attached to this Amendment.

5. Change of bank account for payments

The bank account for payments is changed.

This implies the following changes to the Grant Agreement:

• The bank account is replaced in Article 21.8:

6. Transfer of the Grant Agreement (portability)

As from 1 September 2018, the Grant Agreement is transferred, for the part of the action implemented by the principal investigator, from :

- THE UNIVERSITY OF WARWICK (THE UNIVERSITY OF WARWICK), N/A, established in Kirby Corner Road - University House, COVENTRY CV4 8UW, United Kingdom, GB545270058 (the 'former beneficiary').

to

- Masarykova univerzita (Masaryk Uni), 00216224, established in Zerotinovo namesti 9, BRNO STRED 60177, Czech Republic, CZ00216224 (the 'new beneficiary' No 1), if it acceded to the Agreement by signing the Accession Form (see Annex 3) in the electronic exchange system (see Article 52).

As from this date, the grant becomes a multi-beneficiary grant and the Preamble and all the Articles are adapted to the multi-beneficiary version of the grant agreement.

As from this date, the former beneficiary will no longer assume the role of principal beneficiary and will be replaced by Masarykova univerzita.

This implies the **following changes** to the Grant Agreement:

- The 'transfer date' and the new beneficiary are added to the **Preamble**:
 - 1. 'the principal beneficiary' Masarykova univerzita (Masaryk Uni), 00216224, established in Zerotinovo namesti 9, BRNO STRED 60177, Czech Republic, CZ00216224 represented for the purposes of signing the Agreement by Head of Research & Development Office, principal beneficiary as from 1 September 2018, hosting and engaging the following 'principal investigator':
 - Czech Republic.

The transfert date is at the same time the 'handover date' for the principal beneficiary.

The former beneficiary's obligations continue to apply after the transfer (in particular, Articles 20, 22, 23, Section 3 of Chapter 4, 36, 37, 38, 40, 42, 43 and 44).

The new beneficiary takes over all the rights and obligations of the former beneficiary under the Grant Agreement and has full responsibility for implementing the action and complying with the Agreement. The new beneficiary is however not liable for the way the action was implemented before this date or for debts of the former beneficiary.

The joint and several liability of the linked third parties of the former beneficiary continues to apply after the transfer.

All other provisions of the Grant Agreement and its Annexes remain unchanged.

This Amendment **enters into force** on the day of the last signature.

This Amendment **takes effect** on the date on which the amendment enters into force, except where a different date has been agreed by the parties (for one or more changes).

Please inform the beneficiaries and the principal investigator of the Amendment.
