Dear Sirs

**RE: The Television Licence Agreement between BBC Worldwide Limited ("BBCW") and Ceska Televize (the "Licensee") dated 1 November 2017 (the "Agreement").**

We refer to the Agreement. The Parties have agreed various amendments to the terms of the Agreement which are set out herein. Capitalised words and expressions which are used but not defined in this letter ("**Amendment Agreement No. 1**") shall have the meanings ascribed to them in the Agreement unless otherwise stated herein.

The Parties hereby agree to amend the Agreement as follows:

**Licence Period**

- (i) The Licence Period for the Programme entitled [REDACTED] will have a Licence Period End Date later than originally stated in the Agreement and will now expire [REDACTED] or the earlier of the completion by the Licensee of the Number of Transmissions or if terminated in accordance with the Agreement.
- (ii) In respect of the changes above, the Licence Period End Date for the Programme shall be deemed deleted from Schedule Two and replaced with [REDACTED]

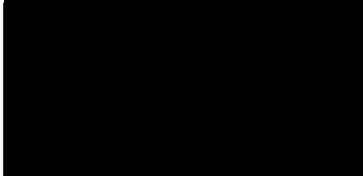

Except as modified herein, all other terms and conditions of the Agreement shall remain in full force and effect. If there is any conflict between the terms of this Amendment Agreement No. 1 and the Agreement, the terms of this Amendment Agreement No. 1 shall prevail.
