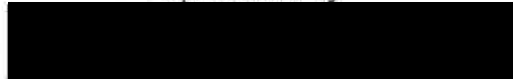

Palacký University Olomouc and University of Warwick (hereinafter collectively "Parties") agree to establish cooperation aimed at implementation of mobility of the Palacký University's researcher specified hereunder (hereinafter the "participant").

Article 1

Within the field of research specified below, Palacký University Olomouc and University of Warwick agree on the following cooperation under terms set out hereunder:

Mobility of the participant from the Palacký University at the premises of University of Warwick within the project Support of Academic mobility at Palacký University Olomouc, CZ.02.2.69/0.0/0.0/16_027/0008482 (hereinafter "the project") implemented by Palacký University Olomouc within the framework of EU operational programme Research, Development and Education (hereinafter "the mobility").

Article 2

Mobility description – goals, focus, schedule.

1. The mobility will be carried out at the Department of Chemistry, University of Warwick under the supervision of the Mentor [REDACTED]
2. Participant of the mobility: [REDACTED] employed at Palacký University Olomouc as Junior researcher, email address: [REDACTED]
3. Both Parties agree on the time schedule of the mobility from January 2019 to July 2019 (hereinafter the "mobility period").
4. Field of research and scientific content of the mobility: Study of the mechanism of new metallodrugs' anticancer activity.
5. For the purpose of specification of further technical details of the scientific content of the mobility and organizational arrangements pertaining thereto, Palacký University will be represented by [REDACTED] (hereinafter "contact person of PU") and University of Warwick will be represented for the purpose of organizational arrangements pertaining to the mobility by [REDACTED] email address: [REDACTED] (hereinafter "contact person of the host institution")
6. Both Parties agree that the results of the common research conducted within the mobility hereunder by employees of both Parties will be published in the form of open access publications. The charges will be covered by Palacký University Olomouc unless specified otherwise.
7. The Parties further agree that the wage of the participant payable in connection with realization of the mobility and the travel expenses of the participant pertaining thereto will be covered by Palacký University Olomouc together with any relevant UK taxes which may become payable for the mobility period. These expenditures will be reimbursed within the framework of the project costs by Palacký University Olomouc on basis of the labor-law relationship with the participant.



8. University of Warwick does not have any financial claims towards Palacký University Olomouc concerning mobility hereunder and University Olomouc does not have any financial claims towards the University of Warwick concerning the mobility.
9. The Parties undertake an obligation to ensure that during the mobility period the participant will perform exclusively non-economic activities.
10. The University of Warwick will communicate to the Palacký University Olomouc any problems or necessary changes regarding the mobility.

Article 3

Parties hereto acknowledge the fact that this agreement is subject to obligatory publication under the Czech Act No. 340/2015 Coll. On Special Conditions of Effect of certain Contracts, Publication of these Contracts and on the Register of Contract (Act on the Register of Contracts) due to the fact that the value of this agreement exceeds CZK 50 000 without VAT.

UP, which shall ensure publication hereof in the Register of Contracts, shall inform the other party of its publication immediately thereafter using the email address of the contact person of the host institution.

Each party shall comply at all times with the General Data Protection Regulation (EU) 2016/679, and any relevant replacement/subsequent EU privacy legislation, for the purposes of performing its obligations and exercising its rights under these terms and conditions ("Data Protection Legislation") and shall not perform its obligations under this Agreement in such a way as to cause the other party to breach any of its obligations under the Data Protection Legislation.

This agreement is concluded as of the date of appending of signatures of authorized representatives of the parties hereto and comes into effect as of the date of its publication in the Register of Contracts in accordance with the aforementioned act.

The parties hereto undertake to refrain from launching to provide any performance hereunder prior to the date of the effect hereof.

Amendments hereto may be made by written agreements of both Parties with signatures of their duly authorized persons on one deed.

Article 4

This Agreement may be terminated in writing by agreement of the Parties with signatures of their duly authorized persons on one deed.

Article 5

The duration of this agreement is determined by the mobility period.
This Agreement is executed in four copies, two copies for each Party.

Article 6

The Parties subscribe to the policy of equal employment opportunity and non-discrimination of person on grounds of race, colour, religion, sex, sexual orientation, age, nationality, marital or veteran status, and physical or mental disability. Palacký University Olomouc, and University of Warwick shall abide by these principles in the implementation of this agreement.

Article 7

Both Parties will sign a Confidentiality Agreement at the same time as signing this Cooperation Agreement.
