It is strictly forbidden that tour escorts either from Eurotours or their clients carry out any cash transactions with the contractual partner.

**Indemnification:**

The contractual partner undertakes to provide the service(s) stated above to all Eurotours guests without restriction and will make sure that they are delivered correctly and without fault. The contractual partner will provide full compensation for any damages whatsoever

which are the result of non-fulfilment of the contract, of actions which are not in keeping with the contract or other deficiencies in the services. Furthermore the contractual partner agrees to indemnify and hold harmless Eurotours and their clients (tour operators) for all claims received by them on behalf of a third party.

Contracting parties agree to full disclosure of this agreement, including personal data contained in the agreement, or to the disclosure to third parties of this agreement or of the essential parts of this agreement under the conditions defined by Act No. 106/1999 Coll., on free access to information, as amended at the date of the request for information or publication, and also declare that nothing in the content of this agreement is considered to be business secrets. The Eurotours acknowledges that the Prague Zoo is bound by Act No. 340/2015 Coll., on treaty register, and agrees that the text of this Contract can be disclosed in the treaty register.

The Eurotours undertakes to cooperate in performing financial control within the meaning of Section 2 e) of Act No. 320/2001 Coll., on financial control in public administration and on amendment to certain Acts (Act on financial control), as amended.

This agreement is valid for EUROTOURS Ges.m.b.H., Kitzbühel and all connected enterprises.
